AN ORDINANCE AMENDING ORDINANCE 342A AS AMENDED AND COMPILED IN SECTION 3-2, ETC, AND REPEALING SECTIONS 14 AND 15 THEREOF AND ADOPTING A NEW SCHEDULE OF WATER RATES, DECLARING AN EMERGENCY AND EFFECTIVE DATE OF JULY 1, 1973.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. Sections 14 and 15 of Ordinance 342A as compiled and in Ordinance 3-2 be and the same are hereby repealed.

Section 2. Section 17 of Ordinance 342-A be and the same is hereby amended as follows:

Minimum meter charge within city, \$3.75 per month. Minimum meter rate outside city, \$4.35 per month. The city commission may fix a flat rate for use of water without meter. The flat rate within the city is \$5.00 per month, including fluoridation. Outside use of water within the city, including sprinkling charges, \$5.00 per year. Yearly flat rate payable in advance including discount is \$54.00. New service meter charge shall be \$150.00 Tap charge only \$100.00.

Section 3. An emergency be and the same is hereby declared so that the effective date of said ordinance shall be July 1, 1973. July 1, 1973 is the commencement of the 1973-74 fiscal year and is the first day thereof and for uniformity and accounting and auditing procedures and to comply with the budget as proposed to the City Commission it is necessary that this Ordinance go into effect on JUly 1, 1973 for all services and water delivered by the City of Warrenton after said date.
