ORDINANCE NO. 694-A

AN ORDINANCE LEVYING TAXES FOR GENERAL MUNICIPAL PURPOSES FOR THE CITY OF WARRENTON, FOR THE FISCAL YEAR COMMENCING AS OF JULY 1, 1980, and ENDING JUNE 30, 1981, UPON SAID FISCAL TAX ROLL, CONFIRMING, APPROVING AND ADOPTING THE BUDGET AS PREPARED, SUBMITTED AND ACTED UPON BY THE LEVYING BOARD AND THE BUDGET COMMITTEE OF THE CITY OF WARRENTON, MAKING APPROPRIATIONS AND DECLARING AN EMERGENCY.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby levied a tax for general municipal purposes for the city of Warrenton for the fiscal year July 1, 1980 to June 30, 1981, inclusive, upon said fiscal tax roll the sum of \$57,741; and that said tax, as aforesaid, is hereby levied upon all of the taxable property within the city limits of the city of Warrenton, Clatsop County, State of Oregon.

Section 2. That there be and is hereby levied a tax for sewer bond indebtedness of the city of Warrenton for the fiscal year July 1, 1980 to June 30, 1981, inclusive, upon said fiscal tax roll, the sum of \$26,700; and that said tax, as aforesaid, is hereby levied upon all of the taxable property within the city limits of the city of Warrenton, Clatsop County, state of Oregon.

<u>Section 3.</u> That the budget for general municipal expenses and purposes and all other applicable figures as budgeted for the city of Warrenton for the fiscal year July 1, 1980 to June 30, 1981, inclusive, upon said fiscal year tax roll as prepared, submitted and adopted by the levying board and budget committee of the city of Warrenton be, and the said budget is hereby, confirmed, approved and adopted and is hereby referred to and made a part of this tax levying ordinance as though set out in full herein, haec verba.

Section 4. That the amounts for the fiscal year beginning July 1, 1980 to and including June 30, 1981, are hereby appropriated as set forth in Exhibit "A", attached hereto and by this reference incorporated herein, said statement being published in the <u>Columbia Press</u>, a newspaper of general circulation in the county of Clatsop, state of Oregon, pursuant to the law.

Section 5. That the Auditor & Police Judge of the city of Warrenton be and is hereby directed to notify in writing the assessor and clerk of Clatsop County, state of Oregon, of the amount of money proposed to be raised by taxation not later than the 15th day of July 1980, accompanied by three true copies of the budget as finally adopted, to each.

Section 6. An emergency is hereby declared to exist for the reason that the city would be without funds to operate its fire and police departments and fix its dikes, or perform any municipal functions, including the supply of water, collection and treatment of sewage and collection of garbage services, without the passage of this ordinance; and, therefore, this ordinance, after passage and approval, shall go into force and effect the 1st day of July 1980.
