

ORDINANCE NO. 719-A

AN ORDINANCE DEDICATING ALL OF LOTS 10 AND 11, BLOCK 31, W. C. SMITH'S WARRENTON LYING WEST OF THE WESTERLY RIGHT OF WAY LINE OF SOUTHWEST CEDAR AVENUE, BEING SITUATED IN THE CITY OF WARRENTON, STATE OF OREGON TO THE PUBLIC FOR STREET PURPOSES.

The City of Warrenton Ordains as follows:

Section 1. That all of Lots 10 and 11, Block 31, W. C. SMITH'S WARRENTON lying West of the Westerly right of way line of Southwest Cedar Avenue, being situated in the City of Warrenton, County of Clatsop, State of Oregon be and the same is hereby dedicated to the public for street purposes.

Section 2. The City, by said dedication is not obligating itself to improve said property or to maintain said property except as it may be otherwise required to do for like properties in accordance with the appropriate ordinances and regulations of the City.

DEDICATION OF CITY STREET TO THE PUBLIC

KNOW ALL MEN BY THESE PRESENTS, That the City of Warrenton, a municipal corporation in the State of Oregon, for and in consideration of the benefits to be derived herefrom, does hereby dedicate to the public as a street and highway and to be and remain a free and open public highway and city street forever, a strip of land all being in the city of Warrenton, County of Clatsop, State of Oregon, described as follows, to-wit:

All of Lots 10 and 11, Block 31, W. C. Smith's Warrenton lying West of the Westerly right of way line of Southwest Cedar Avenue, being situated in the City of Warrenton, County of Clatsop, and State of Oregon. -----.

It hereby dedicates to the public as a free, public and open street and highway and for travel by autos, wagons and other vehicles and for travel by pedestrians and for all street and highway purposes said strip of land as hereinbefore described.
