

ORDINANCE No. 800-A

Introduced by Commissioner William J. KNOWLES

AMENDING SECTION I, ORDINANCE NO. 788-A, BY INCREASING RATES FOR SANITARY SERVICES PROVIDED BY THE CITY OF WARRENTON

The City of Warrenton ordains as follows:

Section I: Said Ordinance No. 788-A shall be amended as follows:

Rates: Section I of Ordinance No. 788-A is hereby amended as follows:

A. Residential collection, including multiple dwellings and mobile home parks: each dwelling unit is charged the minimum for scheduled service.

D. Fort Stevens State Park:

Container charge based on standard rate schedule.  
Cans charged at .95¢/cans per pick-up.

Section II. All other sections and sub-section of Ordinance No. 779-A shall remain unchanged and in effect.

Section III. These rates set forth herein shall insure that the costs of providing refuse service to those desiring its use will be on a cost-effective basis. To continue the existing rates would result in an unfair subsidy of those using these services and an inequitable allocation of the city resources; therefore, the city finds a need exists and the rates, as set forth herein, shall go into full force and effect on 1 May 1987.
