

ORDINANCE No. 926-A

VACATING A PORTION OF CORVALLIS AVENUE (COMMONLY KNOWN AS NE HARBOR PLACE);
FIRST EXTENSION OF EAST WARRENTON, IN THE CITY OF WARRENTON,
COUNTY OF CLATSOP, STATE OF OREGON, AS FULLY DESCRIBED BELOW
(VACATION #84)

WHEREAS, the Warrenton City Commission deemed it to be in the best interest of the city to vacate a portion of Corvallis Avenue (commonly known as N.E. Harbor Place), First Extension of East Warrenton, Warrenton, County of Clatsop, Oregon, fully described below;

Beginning at the S.E. corner of Lot 16, Block 25, FIRST EXTENSION OF EAST WARRENTON, thence South 89 degrees, 49 minutes West along the South line of said Block 25, and the westerly extension thereof to the North line of Railroad Avenue; thence South 82 degrees 50 minutes East along said North line to a point which is South 0 degrees 11 minutes East from the point of beginning; thence North 0 degrees 11 minutes West to the point of beginning.

WHEREAS, City of Warrenton, on its own motion, has petitioned the Warrenton City Commission for vacation of that portion of Corvallis Avenue, (commonly known as N.E. Harbor Place); and

WHEREAS, the Warrenton City Commission has determined that there is no reason why said petition should not be granted and, therefore, a public hearing on this petition is scheduled for the hour of 7:30 p.m., January 5, 1994, in the Warrenton Community Center; and

WHEREAS, due notice of time and place for said hearing was given, as by law required, and as set out in the affidavit of Janet Wright, Zoning Administrator, who posted the required notice, and the affidavit of COLUMBIA PRESS, which printed the newspaper publications, also filed herein; and

WHEREAS, the Warrenton City Commission examined and determined that the abutting property owner was said petitioner and that the owners of a majority of the area affected made no objections; and that the requisite notices were given by posting and publication; and that the public interest would not be prejudiced by vacation of the portion of the street r/w described above, which the petitioner requested be vacated; and that, matters having been determined in favor of the petitioner by the Warrenton City Commission;

NOW, THEREFORE, the City of Warrenton does ordain as follows:

Section 1. That the public r/w in the City of Warrenton, Clatsop County, State of Oregon, described herein by, and the same is hereby vacated and said vacation herein described is hereby made a matter of public record; and it is expressly provided that City of Warrenton, shall forthwith pay the costs of publication of notices and the necessary changes of public record, as required by law; and it is hereby provided that the Zoning Administrator shall file with the clerk, the assessor and the surveyor of Clatsop County, a certified copy of this ordinance. Nothing contained herein shall cause or require the removal or abandonment of any sewer, water main conduit, utility line, pole or any other thing used or intended to be used, for any public service.
