# AMENDING ORDINANCE NO. 918-A BY ADDING AND DELETING A LEGAL DESCRIPTION TO VACATE A PORTION OF ARTHUR STREET

## (COMMONLY KNOWN AS N.E. IREDALE AVENUE) BETWEEN BLOCKS 24

## AND 25, FIRST EXTENSION OF EAST WARRENTON, CITY OF

### WARRENTON, COUNTY OF CLATSOP, STATE OF OREGON, AS FULLY

#### **DESCRIBED BELOW (VACATION #82)**

WHEREAS, Ordinance No. 918-A incorrectly described the legal description of the street to be vacated; and

WHEREAS, the correct description of this street is as follows:

That portion of Arthur Street (Commonly known as N.E. Iredale Avenue) lying between the South line of Salem Avenue (Commonly known as N.E. 1st Street) and the North line of Corvallis Avenue (Commonly known as N.E. Harbor) in the Plat of FIRST EXTENSION OF EAST WARRENTON; and

WHEREAS, the City of Warrenton, on its own motion, has petitioned the Warrenton City Commission for vacation of that portion of N.E. Iredale Avenue as fully described above; and

WHEREAS, the Warrenton City Commission has determined that there is no reason why said petition should not be granted and, therefore, by Resolution No. <u>826</u>, scheduled a public hearing on this petition which was heard at the hour of 7:30 p.m., Wednesday, September 15, 1993, in the Warrenton Community Center; and

WHEREAS, due notice of time and place for said hearing was given, as by law required, and as set out in the affidavit of Janet Wright, Zoning Administrator, who posted the required notice, and the affidavit of COLUMBIA PRESS, which printed the newspaper publications, also filed herein; and

WHEREAS, the Warrenton City Commission examined and determined that the abutting property owner was said petitioner and that the owners of a majority of the area affected made no objections; and that the requisite notices were given by posting and publication; and that the public interest would not be prejudiced by vacation of the portion of the street r/w described above, which the petitioner requested be vacated; and that, matters having been determined in favor of the petitioner by the Warrenton City Commission; and, NOW, THEREFORE, the City of Warrenton does ordain as follows:

Section 1. That this Ordinance is hereby amended to correct the legal description; and it is hereby provided that the Zoning Administrator shall file with the clerk, the assessor and the surveyor of Clatsop County, a certified copy of this ordinance. Nothing contained herein shall cause or require the removal or abandonment of any sewer, water main conduit, utility line, pole or any other thing used or intended to be used, for any public service.
