PRESCRIBING THE FORMS FOR NOMINATIONS FOR

AN ELECTIVE CITY OFFICE AND SUPPLEMENTAL

CANDIDATE FORMS AND DECLARING AN EMERGENCY

The City of Warrenton hereby ordains as follows:

<u>Section 1:</u> The form for the supplemental declaration of candidacy and nomination by petition be and same is hereby prescribed as shown on Exhibit A attached hereto.

<u>Section 2:</u> The form for nomination by petition be and the same is hereby prescribed as shown on Exhibit B attached hereto.

<u>Section 3:</u> There shall be no filing fee required for nomination by petition.

<u>Section 4:</u> EMERGENCY CLAUSE: Clatsop County Elections Department advised the City under date of August 3, 1994, that candidates for City election, may be included in the voter's pamphlet at no charge to the candidate if the candidate files a document in the form of the supplemental declaration attached hereto. As the filing deadline for candidates is prior to the expiration of the 30-day normal effective time for this ordinance, the City finds that it is an emergency for the assistance of candidates for City elections that this ordinance be passed and go into effect immediately upon its passage.
