Staff would work with Counsel Nancy Werner on developing a new model.

**CALL TO ORDER:** Mayor Carson called the Regular Meeting to order at 7:30 p.m. in the City Council Chambers followed by opening ceremonies.

<u>National Library Week Proclamation</u> – Mayor Carson read a proclamation proclaiming April 8-14, 2012 as National Library Week and presented it to Penny Hummel, Library Director. Ms. Hummel said the Library would be celebrating with a concert on April 14.

<u>Grange Month Proclamation</u> – Mayor Carson read a proclamation proclaiming the month of April 2012 as Grange Month and presented it to Sara Kingsborough. Ms. Kingsborough gave a background on the grange and the services they provided in the community.

<u>Introduction of New City Auditors</u> – Greg Ellis, City Administrator, said that he along with Councilor Ares and Sue Engels, Finance Director, had reviewed the auditing services RFPs. Ms. Engels introduced Roy Rogers and Tamara Graham from the firm of Pauly Rogers & Co. P.C. whom were selected to receive the three year contract.

Councilor Ares said the City had been using the same auditing company for 11 years, and after review of the RFP's Pauly Rogers & Co. was the clear choice.

Mr. Rogers spoke about the firm and Ms. Graham would be in charge of the audit.

<u>Consolidation of City Offices</u> – Mr. Ellis said at the March 14 URA meeting he had introduced a proposal to consolidate several City departments in the lower floor of the new police facility. He had received correspondence from several citizens whom were not in favor of moving the departments. He was still in favor of consolidating, but withdrew his suggestion of moving to the new police facility.

The Council was in support of Mr. Ellis' proposal withdrawal as they thought these departments should stay downtown. They were in support of the consolidation.

Bob Cornelius, resident of Canby, supported consolidation but encouraged the Council to take time and use prudent planning.

Chris Nichols, Johnson Controls, Inc., thanked the Council for their change in position.

Tony Helbling, Wilson Construction Co., said they agreed with the City consolidation but wanted to keep it downtown.
