COUNCILOR COMMENTS & LIAISON REPORTS: Councilor Carlson thanked the Mayor and Council for the last few years and the Baptist Church for praying for the Council every month. He also thanked his wife, City staff, and the citizens. The Chamber Annual Dinner would be on January 24.

Ordinance 1302 - **Councilor Carson moved to approve Ordinance 1302, AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH COMMUNITY PLANNING WORKSHOP (CPW) FOR PROFESSIONAL SERVICES TO UPDATE THE CITY'S PARK MASTER PLAN AND PARK ACQUISITION PLAN; AND DECLARING AN EMERGENCY to come up for second reading on January 21, 2009. Motion was seconded by Councilor Carlson and passed 6-0 on first reading.

NEW BUSINESS: Presentation to Councilors Blackwell, Carlson, and Carson – Mr. Adcock said he appreciated the support from the outgoing Councilors.

Council President Daniels presented the Councilors with plaques.
