CANBY CITY COUNCIL WORK SESSION MINUTES April 2, 2008

Mayor Thompson called the Work Session to order at 6:00 p.m. in the City Hall Conference Room. The Council met to receive an overview of the new proposed police and court facility.

Jeff Humphries and Brett Hansen, Group MacKenzie Architects, gave an overview of everything that had been done so far in designing a new police and court facility. They had toured existing facilities and distributed questionnaires to key staff to provide input on what was needed. They wanted to build a facility that had a projected growth of 30 years. The building was being developed from big picture ideas. Single floor and second floor schemes were looked at and each room was diagramed in detail and defined where things would go. Slides were shown of the various diagrams and parking examples. It had been narrowed down to five schemes and those were described. Images of possible designs were looked at for the exterior of the building. Simple structures that had a symbolic or historic look to them made of masonry, stone, or brick were preferred. All of the buildings would be one story, except the police building which would be two stories. It had been programmed into it the ability to scale back the building or expand the building as needed. They thought they would use different materials to identify different areas, such as the firing range, to contrast the major functions of the buildings from one another. The location that would be used for stormwater and how it would be handled was discussed. Circulation and connections in the buildings, the private and public accesses, along with current ideas for the floor plan were reviewed.

Councilor Helbling asked what the driving factor would be, the choice of the way the roof line looked or the passive solar or the active use for heating, cooling, and lighting of the building.

Mr. Hansen said it would be a play of both.

Councilor Helbling said it cost money to operate it after it was built and it was one of the sells they had to make to citizens. The community has been educated about it and it made the bond easier to pass if it was designed green.

Mr. Adcock suggested having moveable interior walls.

Councilor Carson wanted to see their projection numbers because he thought they should make it all two stories at the beginning. They should build it, and just leave it vacant until they needed it in case they had fast growth.

Councilor Wayne Oliver arrived at 7:05 p.m.

They discussed the reason for the large evidence area, and that currently they were using the City shops for car evidence storage.

Councilor Carlson thought that information should be shared with the public.

A discussion took place regarding the training facility. It could be used by other local jurisdictions and could be an economic development tool for the community.

Mayor Thompson wanted more information on how this would work.

Councilor Carlson wanted to know of the 41% of the budget that went to the Police Department, how much of it they would save if they had the new police facility.

In the next work session they would refine the design and describe more the character of the building and its components. They would have the projected construction costs as well.

Councilor Carson wanted to know what materials were going inside.

Mayor Thompson adjourned the Work Session at 7:20 p.m.

Lynn Olson, advisor to the Builders Club at Baker Prairie, said this was their first year for Builders Club. She explained the service activities they were doing.

Ashley West, student at Baker Prairie, explained more how they helped the community this year.

Amy Wery said she was the Treasurer for the Canby High School Key Club. They helped with several community projects and organized the blood drive at the high school. They were learning a lot about community involved leadership.

He thought they should let churches have a year window to choose whether or not to opt in or out of the fee. After that one year window, from that point on all the churches would be under the fee. His concern was a first amendment issue, separation from church and state. He was concerned this would set a precedent for establishing more fees and the churches would not be able to afford it.

MAYOR'S BUSINESS: Mayor Thompson said the Mayor's Prayer Breakfast would be on May 1 at Cutsforth's Town Hall at 6:30 a.m. On Thursday, April 17, Metro would be having a Neighboring Cities meeting at the Canby Adult Center and Canby had been asked to host it.

Councilor Daniels said there was an error in the newspaper for the cost of the four Canby Community Concerts. It was \$50 instead of \$40.

<u>Councilor Helbling</u> said that Canby Business Development's last meeting would be April 15. The Planning Commission still had two openings, and they received one application.
