COUNCILOR COMMENTS & LIAISON REPORTS: Councilor Blackwell said the Library had a wonderful bookstore run by the Friends of the Library. In October The Friends Board authorized payments of \$3,000 for the children's collection, \$1,200 for periodical subscriptions, purchased a refrigerator for the staff, and \$3,750 for family night programming and movies.

Motion was seconded by Councilor Helbling and passed 6-0.
