The City Council and Urban Renewal Agency met in a work session to discuss a proposed new police and court facility.

Mark Adcock, City Administrator presented information about his tour of police facilities in Bend, Oregon; Santa Ana, California; and City of Orange, California. He stated that the most insightful information gained from these tours was the universal need to have built bigger police facilities. Canby's current police facility does not meet current Police Facility Building Code Standards, safety standards and they need more room.

Margaret Yochem, Transit & General Services Director reviewed a handout detailing information about the current Police Department and the need to build a new police facility.

A discussion took place regarding how a new police and court facility would be funded using Urban Renewal funds along with a supporting bond.

Mr. Adcock summarized the Council consensus that Urban Renewal money would be set aside into a building fund for the Police Department in the out years. Staff would continue to work on the conceptual side, bond strategies, and come back to Council in the future with a strategic plan.

The work session was adjourned at 8:25 PM.
