

**CANBY CITY COUNCIL  
WORKSHOP MINUTES  
December 1, 2004**

**Presiding:** Mayor Melody Thompson

**Council Present:** Walt Daniels, Georgia Newton, Wayne Oliver, Randy Carson, and Teresa Blackwell.

**Staff Present:** City Administrator Mark Adcock, Finance & Court Services Director Chauncey Seifried and City Recorder Pro Tem Kim Scheafer.

**Others Present:** Roger Harris, Lila & Curtis Gottman, Charles Blackwell, Rhonda Hutchinson, and Bob Watson.

Mayor Thompson called the session to order at 6:05 p.m. A light dinner was served.

The Council met in a workshop session to discuss the roles and responsibilities of the City and General Canby Day Committee if the committee became a non-profit 501(c)(3) organization. The Committee wrote a list of responsibilities. The Committee wanted general support from the City and to waive some fees.

Councilor Daniels asked if fees would be charged to non-profit parade participants. Ms. Gottman said no.

Councilor Carson asked about what types of things the General Canby Day Committee gave back to the citizens. Ms. Gottman said they paid for the fireworks, trophies for different events, advertising, meals for the coronation, and decorations. Under the ordinance, all the funds went to the event.

Councilor Newton said she did not know what the city could do every year, such as police and garbage service fees being waived.

Mayor Thompson said in regard to a Council member on the Committee, they would continue having a liaison if someone on the Council was willing to serve as one.

A discussion took place regarding the costs associated with police and garbage services. Waiver of police service fees would be handled on a year to year basis depending upon the City's budget. They needed to review the garbage service agreement to see if there was a provision for this event. Complaints would be referred directly to the General Canby Day Committee. The Committee would become an independent autonomous group.

The Council wanted to see the General Canby Day Committee give back funds to the community if they had extra. The current ordinance would be rescinded and the committee would be governed by its own by-laws. The Committee would be serving as General Canby Days Inc. The goal was to keep the event free.

Mayor Thompson adjourned the session at 7:05 p.m.

**CALL TO ORDER:** Mayor Thompson called the regular session to order at 7:30 p.m., followed by the opening ceremonies.

Kiwanis Food & Toy Drive Proclamation – Mayor Thompson presented Mr. Greg Perez with a proclamation proclaiming December 12 – 18, 2004 as Canby Kiwanis Food & Toy Drive. Mr. Perez thanked them and hoped they could visit the warehouse to see their operation.

Certification of November 2, 2004 Mayor & City Council Election – Mayor Thompson read the certification of the November 2, 2004 General Election regarding the Mayor and City Council election. The official count of votes from Clackamas County:

**MAYOR -**

Melody Thompson - 4,551, Write-In - 150, Over Votes - 0, Under Votes - 2,416.

**CITY COUNCIL -**

Walt Daniels - 3,812, Roger Keith Harris - 3,454, Randy Carson - 3,577, Teresa Blackwell - 3,725, Write-In - 222, Over Votes – 4, Under Votes 13,674.

Certification of November 2, 2004 Measure 3-139, 4.98 Acre Annexation Proclamation – Mayor Thompson read the certification of the November 2, 2004 General Election regarding Measure 3-139. The measure passed with an official count of votes from Clackamas County:  
Yes – 3,610, No – 3,076, Over Votes – 2, Under Votes – 429.

Certification of November 2, 2004 Measure 3-141, 4.57 Acre Annexation Proclamation – Mayor Thompson read the certification of the November 2, 2004 General Election regarding Measure 3-141. The measure failed with an official count of votes from Clackamas County: Yes – 3,158, No – 3,488, Over Votes – 3, Under Votes – 468.

Certification of November 2, 2004 Measure 3-142, 9.74 Acre Annexation Proclamation – Mayor Thompson read the certification of the November 2, 2004 General Election regarding Measure 3-142. The measure failed with an official count of votes from Clackamas County: Yes – 3,121, No – 3,568, Over Votes – 2, Under Votes – 426.

Certification of November 2, 2004 Measure 3-143, .97 Acre Annexation Proclamation – Mayor Thompson read the certification of the November 2, 2004 General Election regarding Measure 3-143. The measure passed with an official count of votes from Clackamas County: Yes – 3,417, No – 3,242, Over Votes – 1, Under Votes – 457.

Plaque for Councilor Johnson - Mayor Thompson read from a plaque that thanked Mr. Pat Johnson for serving on the City Council. Mr. Johnson was unable to attend the meeting.

**COMMUNICATIONS:** None.

**CITIZEN INPUT & COMMUNITY ANNOUNCEMENTS:** Lila Gottman, resident of 10823 S Mulino Rd, said that students from Carus Elementary School had submitted the button designs for General Canby Day this year. The theme was Our Country, Our Community. Buttons would be displayed around town and the public would be able to vote on a design they liked.

**MAYOR'S BUSINESS:** Mayor Thompson said that she had attended the swim meet at the swim center last weekend and had seen the improvements made at the pool.

On Monday, November 29, she along with Mr. Adcock attended a City Manager/Mayor meeting regarding the results of the library levy. The cities would have a greater say in the County and there would be a coordinated effort to help with the declining funding for libraries. Administrator Adcock reviewed the items of discussion of that meeting.

Mayor Thompson said she along with Ms. Beth Saul had attended a meeting with the Riverside Neighborhood Association regarding adopting or advocating the Emerald Necklace plan. The Association asked if they could also attend the Arndt Road meeting.

**COUNCILOR COMMENTS & LIAISON REPORTS:** Councilor Daniels said in regard to the Kiwanis food basket program, people needed basic food items. Mr. Perez said they wanted non-perishable food and non-dented canned foods.

Councilor Newton thanked the Canby Chamber of Commerce for the light parade and decorating Wait Park. The City let the Chamber use their new sound system. This event happens the first Saturday after Thanksgiving each year.

Councilor Blackwell said they had received two applications for the Planning Commission. Advertising had been on-going for some time. She thought they should set up a time for interviews after their workshop on the 11<sup>th</sup>. Councilor Carson said they could make a decision at their next meeting on what they wanted to do. Councilor Blackwell said one current Planning Commission member was asking to be reappointed and the other applicant was new. Councilor Carson said anyone interested should get their application in.

Councilor Daniels said there were two openings on the Bike & Pedestrian Committee.

**CONSENT AGENDA: \*\*Councilor Carson moved to approve Accounts Payable of \$136,261.55; Minutes of the November 15, 2004 City Council Workshop; and Minutes of the November 17, 2004 City Council Workshop, Regular Meeting, and Executive Session. Motion was seconded by Councilor Blackwell and passed 5-0.**

#### **RESOLUTIONS & ORDINANCES:**

Resolution 886 – **\*\*Councilor Daniels moved to approved Resolution 886, A RESOLUTION ACCEPTING THE RESULTS OF NOVEMBER 2, 2004 ELECTION, PROCLAIMING ANNEXATION INTO THE CITY OF 4.98 ACRES DESCRIBED AS TAX LOTS 2300 AND 3300 OF TAX MAP 3-1E-34 LOCATED ON THE EAST SIDE OF SOUTH WALNUT STREET, BETWEEN SOUTH WALNUT AND SOUTH MULINO ROAD, AND SETTING THE BOUNDARIES OF THE PROPERTY TO BE INCLUDED WITHIN THE CITY LIMITS. Motion was seconded by Councilor Carson and passed 5-0.**

Resolution 887 – **\*\*Councilor Carson moved to approved Resolution 887, A RESOLUTION ACCEPTING THE RESULTS OF NOVEMBER 2, 2004 ELECTION, PROCLAIMING ANNEXATION INTO THE CITY OF .97 ACRES DESCRIBED AS TAX LOT 1500 OF TAX MAP 3-1E-28DD LOCATED AT 1063 NE TERRITORIAL ROAD ON THE SOUTHWEST CORNER OF N. PINE STREET AND NE TERRITORIAL ROAD, AND SETTING THE BOUNDARIES OF THE PROPERTY TO BE INCLUDED WITHIN THE CITY LIMITS. Motion was seconded by Councilor Blackwell and passed 5-0.**

Ordinance 1153 – Community Development and Planning Director John Williams said the last time the sewer use ordinance was updated was in 1991. Most of this was cleaning up and reorganizing the ordinance to meet state and federal rules. The ordinance had already been reviewed and approved by the Department of Environmental Quality.

Councilor Carson thanked Mr. Tramel and the WWTP Department.

Mayor Thompson said the title of the ordinance said it was regulating the discharge of wastes and storm water. Mr. Tramel said there would be a new ordinance that addressed the storm water system. Mr. Williams said the City had a storm water plan since 1994. Mr. Tramel said there was reference to storm water that related to the collection system and they prohibited hazardous waste and toxic waste to go into the storm water system. Mayor Thompson asked if any industrial/commercial users had any comments, and Mr. Tramel said they did not.



**\*\*Councilor Carson moved to approved Ordinance 1153, AN ORDINANCE REGULATING THE DISCHARGE OF WASTES TO THE CITY OF CANBY SANITARY AND STORM SEWER SYSTEMS, LIMITING SUCH DISCHARGES ONLY TO THOSE OF ACCEPTABLE TYPES, CHARACTERISTICS, OR CONCENTRATIONS; ESTABLISHING A SYSTEM OF WASTE DISCHARGE PERMITS AND USER FEES; PROVIDING FOR ENFORCEMENT; REPEALING ORDINANCE NO. 868, ENACTED SEPTEMBER 18, 1991 AND DECLARING AN EMERGENCY to come up for second reading on December 15, 2004. Motion was seconded by Councilor Blackwell and passed 5-0 on first reading.**

Ordinance 1155 - **\*\*Councilor Newton moved to approve Ordinance 1155, AN ORDINANCE VACATING TEN FEET OF THE PUBLIC RIGHT-OF-WAY ON THE WEST SIDE OF NORTH OAK STREET BETWEEN TAX LOTS 00211 AND 00208 OF MAP 3-1E-33AA. Motion was seconded by Councilor Daniels and passed 5-0 by roll call vote.**

Ordinance 1162 – Police Chief Ken Pagano said that the Police Department was in a vehicle replacement program of replacing two patrol cars a year. Chief Pagano thanked Fleet Services Supervisor Joe Witt for all he had done. They were replacing a 1995 Chevrolet and a state lease vehicle.

**\*\*Councilor Daniels moved to approve Ordinance 1162, AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH LANDMARK FORD OF TIGARD, OREGON FOR THE LEASE/PURCHASE OF TWO (2) 2005 FORD CROWN VICTORIA POLICE INTERCEPTORS WITH POLICE EQUIPMENT PACKAGES FOR THE CANBY POLICE DEPARTMENT AND DECLARING AN EMERGENCY to come up for second reading on December 15, 2004. Motion was seconded by Councilor Carson.**

Councilor Daniels asked if switching from a Chevrolet to a Ford was a general trend. The Chief said that Chevrolet did not make the police package anymore.

**Motion passed 5-0 on first reading.**

Ordinance 1165 - **\*\*Councilor Carson moved to approve Ordinance 1165, AN ORDINANCE CONCERNING REAL PROPERTY COMPENSATION; ADOPTING PROCEDURES FOR PROCESSING DEMANDS AND DECLARING AN EMERGENCY. Motion was seconded by Councilor Blackwell and passed 5-0 by roll call vote.**

Ordinance 1167 – Mr. Adcock said they had received a bid from a vendor they were not familiar with and would bring this ordinance back at the next meeting.

**NEW BUSINESS: Appointment of City Recorder Pro Tem – Mayor Thompson said that she was appointing Mr. Adcock as City Recorder Pro Tem while Kim Scheafer was absent.**

**CITY ADMINISTRATOR'S BUSINESS & STAFF REPORTS:** Update on Future Facility Plan – Transit & General Services Director Margaret Yochem said they had ten meetings and three of those were with the Task Force. They did a preliminary assessment and introduced preliminary budget models and were reviewing demographics. They were hoping to have a recommendation in January. Ms. Yochem said they were not doing any remodeling while this process was going on. Ms. Yochem said anyone could attend these meetings.

Ms. Yochem said in regard to transit, they had received word that they were not on the list for appropriations. Ridership was good and they would be putting in restrooms at the transit center and a new shelter had been installed at the Canby Adult Center. She asked that people use the bus shelter and not the doorway of the Adult Center.

Mr. Adcock said Attorney Kelley attended a training session on Measure 37 that day. Mr. Kelley gave an overview of what he had learned at the training session. The appraisal costs would be astounding.

Councilor Blackwell asked who paid for the appraisal. Mr. Kelley said that anyone who owned property was qualified to testify as to the value of their property. They had to agree to the underlying assumptions and the City's appraisal could be very different. If the regulation was a State enforced requirement, the City would have no authority to waive it and DLCD would more than likely sign a waiver. They were waiting to see what claims would be filed and how they were handled.

Mr. Adcock said that the City received from the League of Oregon Cities and City County Insurance Services a safety and risk management award for Fiscal Year 2003-2004.

Mayor Thompson said she got a message from the Chief regarding setting up a meeting with some law enforcement partners in regard to sharing gang information. She appreciated his initiative.

**CITIZEN INPUT:** Ms. Gottman said that the Canby Adult Center would be having a holiday bazaar on Saturday from 9:30 – 1:30. Next Saturday they would be having a Bingo night.

Mayor Thompson read the executive session format and recessed the regular session at 8:41 p.m.

Mayor Thompson reconvened the regular session and immediately adjourned at 9:31 p.m.
