The Wastewater Treatment Plant Department gave a status report and updated the Council on their current performance measures.

Mayor Taylor adjourned the session at 7:20 p.m.

REGULAR SESSION
DECEMBER 6, 2000

Mayor Scott Taylor presiding. Council members present Walt Daniels, Terry Prince, Barry Lucas, Randy Carson, Shirley Strong, and Roger Harris.

Mayor Taylor called the regular session to order at 7:30 p.m., followed by the opening ceremonies.

PROCLAMATIONS: Kiwanis Toys for Tots and Christmas Food Basket Week - Mayor Taylor read the proclamation declaring December 1 - 23, 2000 the as a time to call upon citizens to participate with donations of food and toys to assure that those families and children less fortunate will have a better Christmas. Nancy Murphy, President of the Kiwanis Club of Canby, was on hand to accept the proclamation and the donations presented and introduced the other Kiwanis members who helped gather the food and toys, Duane and Janice Weeks, Robin Adcock, Clarence Kaufman, Janine Brooks, Barbara Kirwan, and Walt Daniels. She brought a

sample food basket for a family of five to give the Council and audience an idea of what gets delivered every Christmas. Approximately 250-275 baskets will be delivered this season within the local Canby School District area. Volunteers are more than welcome to help deliver on Saturday, December 23, 2000 at 8:00 a.m.

Certification of November 7, 2000 Elections Results for Mayor and Council - Mayor Taylor read the results of the elections hereby electing Terry Prince to serve a two year term as Mayor for the City of Canby and Teresa Blackwell, Randy Carson, and Patrick Johnson to serve four year terms on the Canby City Council.

Certification of November 7, 2000 Election Results for Measure 3-1 Annexation - Mayor Taylor read the results approving that 1.7 acres located south of NE 22nd Avenue and west of N Maple street be annexed into the City of Canby.

Certification of November 7, 2000 Election Results for Measure 3-24 Canby City Charter Amendment - Mayor Taylor read the result denying the Canby City Charter be amended to eliminate term limits for Canby Utility Board Members.

CITIZEN INPUT ON NON-AGENDA ITEMS:

Joe Driggers - Addressed the Council as a Board member of the Canby School District. He requested that Council review the graph in their packets of the test scores of the Canby School District and other Clackamas County districts. The graph represents the percentage of students that have met the state benchmark at each of the 3rd, 5th, 8th and 10th grade levels in math. The hope is to continue to raise the level of these scores and he is here tonight to ask for more community and City support for the schools through volunteering, serving on committees, etc. 78% of Canby 3rd graders met or exceed the state benchmark for reading; for the rest of the schools in the County, that number is 90%. 67% of Canby 3rd graders met the benchmark for math and the County average is 85-87%. He was urging Canby residents not to become complacent about their schools, but become actively involved and visit and volunteer at the schools to help increase the percentages.

Back to School information had just been received by the Mayor, to set up events in co-operation with the School District to have parents go back to school for a day to familiarize themselves with current classrooms. Less than 25% of adults have children in school today. The hope is to re-engage the community and to encourage people who no longer have children in school to stay connected.

Mr. Driggers hopes that the City as an employer would encourage comp time or paid time off so that employees could volunteer at the schools. The School District has just hired a volunteer coordinator to work with community groups.

Councilor Daniels remembers that people came to Canby to live for "livability" and "good schools". So this report is a wake up call for people to get involved and return Canby to the level many remember.

Councilor Prince asked if the School District was working towards lower-sized classrooms?

Mr. Driggers stated that part of the governor's budget is additional dollars in K-12 that is for school improvement and smaller classrooms would seem to apply. The goal is that Oregon students will be at benchmark statewide at 90% for third grade reading.

Councilor Daniels said there is a need for more individual instruction done by volunteers than in the past due to non-English speaking students and children entering school unable to read.

The Mayor paraphrased something he had heard that stated that if you don't know how read by second grade, there is a rapidly declining separation of where a student needs to be and the impact on later years. 84% of people who come through the prisons do not even have a GED. One of the prison's most successful programs to change criminal behavior is education; it will turn lives around.

CONSENT AGENDA: **Councilor Daniels moved to adopt the consent agenda: minutes of the workshop and regular meeting, November 15, 2000; accounts payable in the amount of \$320,305.25 and appointment of Jim Newton to the Canby Utility Board; granting a waiver of fees an street closures to Canby Junior Festival of Jazz and approval of a request for the use of city sidewalks for "Steps for Life" Walk. Motion seconded by Councilor Lucas and passed 6-0.

It was decided to pull the appointments to the City Budget Committee off the consent agenda and move to New Business (D).

Councilor Strong questioned if Georgia Newton were still serving on the Canby Utility Board and was told that due to the failure of removing term limitations from the Board, she was no longer serving.

Councilor Lucas announced that there were still openings on that Board; he would appreciate people stepping up and volunteering to serve.

COMMUNICATIONS: Muscular Dystrophy Presentation - Patricia Katen, local organizer for the MDA's "Lock up" at Jarboe's Grill scheduled for Thursday, December 14th, was on hand along with Master Travis Maier and Sheri Renhard who both have forms of muscular dystrophy. She thanked the over 200 participants who have already volunteered to take part and welcomed anyone who had not yet signed up to please participate in this worthwhile endeavor.

Sheri Renhard, as an active member of Canby, also thanked everyone for their support - when people are asked to help, they do. She and her daughter have one of the 43 forms of muscular dystrophy and without the MDA, they wouldn't be getting the kind of care and knowledgeable treatment they are now.

Mayor Taylor explained that for those who are not going to be "serving time" during the fundraiser, be on hand to accept calls from friends to "pay bail". It will be fun as well as

rewarding.

NEW BUSINESS: Recycling Presentation - Fred Kahut from Canby Disposal, KB Recycling, West Linn Refuse and Recycling and Roger Reif were on hand to explain a new recycling program and brought an example of the latest recycling receptacle currently being used in the City of West Linn. Mr. Reif spoke to Council requesting to start a similar program in our jurisdiction. Mr. Reif stated that the recycling efforts in Canby are 37.4; after initiating the program in West Linn, their percentage is now 56.17%.

There is currently an Oregon statute which strongly requests that cities have recycling efforts that exceed 50% and Canby is not alone with other cities in falling well below that percentage. In order to bring Canby up above the 50%, they would like to institute a program similar to the one that is in West Linn. Permission is being requested to distribute to Canby and rural customers a 95 gallon recycling can. Educational information will be sent prior to making the change. The cost to the customers will be nothing. The can is able to co-mingle all recycling except for motor oil and glass, which can continue to be placed in the current yellow bin. Hopefully, in two years everything will be self contained, glass should be added by then, and will look more attractive as well as improve recycling efforts.

The recycling company has budgeted \$255,000 for the purchase of the new cans and hope to recoup costs by lower workers' compensation insurance through new trucks that will not require workers to pick up the containers. One driver will be able to do the recycling route but due to the size of the container, most customers will not have their can at curbside every week so the route can be covered faster. Currently, St. Helens West Linn, and Keizer are the cities who have initiated this program so it is on the cutting edge of recycling and Canby will be one of the first.

Mr. Reif answered Councilor Strong that there would be a green garbage can, a brown yard debris can, a yellow bin for motor oil and glass, and now a new gray recycling can.

Councilor Lucas asked if that were the only can size and Mr. Reif explained that the 95 gallon can would be distributed and the recycling company would then work with the customer on alternatives for a smaller can, if requested.

Mr. Kahut stated that with permission and the go-ahead from Council, the program could be started within 90 days. The carts are readily available and just need to be stamped with the City logo.

Councilor Daniels commended them for coming to the Council with new ideas to keep the City on the cutting edge of recycling efforts.

Councilor Carson also commended the transfer station operation. It is nicely landscaped, there is no noise or no smell and appreciate their efforts to blend into the area.

Mayor Taylor felt that people who have moved into the area would be surprised to know that the facility was a recycling transfer station. He encouraged citizens to stop by and visit the facility.

Mr. Kahut said that his company could set a day to do that.

Councilor Strong wanted the public to know that if a recycling container breaks, it can be replaced by just a phone call to the recycling company.

Mayor Taylor recessed at 8:15 p.m. to allow for set up for the next presentation and reconvened the meeting at 8:25 p.m.

Canby Public Transportation Task Force Update and Presentation - Mayor Taylor explained that there was a window of opportunity through the legislature for the City of Canby to establish its own transportation system. A volunteer committee was formed to research this opportunity and Barbara Kirwan, Chairman of the 26 member Task Force and Dave Eatwell, Canby Downtown Revitalization Program Director explained about the purpose and plans of the Task Force. Ms. Kirwan explained that the membership included a cross-section of the community from youth to senior citizens and the Task Force was then divided into six sub-committees. All meetings are open to the public and meet once a month at the Canby Adult Center, with sub-committees meeting during the month and reporting to the Task Force committee meeting.

A computer slide show was presented stating that the City is currently going through a periodic review process as well a public process to design the downtown. It outlined the transportation survey, task force development and mission and a comprehensive assessment of Canby's transportation needs. Dr., Thomas Sanchez was commissioned to carry out the survey.

Dr. Thomas Sanchez, PhD from Portland State University was introduced and summarized the Canby Community Transportation Needs Assessment report. The survey was sent to 2000 households and 500 returned the inquiry representing approximately 1,400 residents. Highlights from the survey showed that 60% of Canby's residents work outside the community, there were demands for non-work travel, the continued use for walking and biking modes of travel within the City, showing bus and taxi were the least used modes. He was pleased with the response and felt that it was a good representation.

There was great interest for anticipated levels of service to the Oregon City area and non-stop service to Portland and the I-5 corridor with frequent, reliable and fast service. There were also demands for travel to downtown Canby, commercial 99E corridor area, 13th & Ivy area, and Canby High School area. He commended the committee for accessing the needs of the community.

The Task Force then established a strategic plan: system strategy, routes & schedules, specific needs and services, special needs and services, implementation time line, staff and equipment needs, and available resources such as grants and loans.

Chris Muller, a Canby High student and task force member, found that the students wanted to be able to go to major shopping centers and concerts in the major metropolitan area. They also wanted transportation home after sporting events.

The petition to withdraw from the TriMet service area must be filed by August 20, 2001. Following the approval of that petition, the Canby bus service district must be up and running by January of the year following having ordered the equipment, staff hired and trained and facilities. The petition needs to be supported by specific data: current level of service and destinations by TriMet, potential service Canby would better provide including teaming up with other cities and budgetary concerns. It would need to show available funds, capital expenses for equipment, and operational expenses. It needs to be emphasized that this is the last opportunity Canby will have to withdraw from the TriMet service district.

In order to meet the dead lines, the Task Force will complete the draft of the Basic Transportation System Plan by April 1st, 2000, the first draft of the Withdrawal Petition for review and approval by City Council is scheduled for May 18, 2001 and the final draft completed by June 20, 2001. This will allow a safety cushion before the August 20, 2001 deadline. The first bus will need to be up and running by January, 2002.

Councilor Prince was concerned about the short time line from the time the petition is filed and needing to have the first bus rolling. It had been mentioned in one of the prior task force meetings that it could take between nine months to a year to order and receive a bus. Dave Eatwell responded that there would need to be some plans to fall back on, such as contract with TriMet or other services until our equipment arrived. These issues would be addressed in the implementation plan.

Councilor Prince would prefer for Canby to in some way start up rather than contract with TriMet.

Councilor Lucas questioned if the Task Force was getting any help from other cities who have gone through this, such as Sandy or Estacada. Dave Eatwell responded that there is a member of the Task Force from Wilsonville and the group has received copies and research carried out by Sandy and Wilsonville when they went through their respective processes. Councilor Lucas said they reached and exceeded their rider ship goals within months.

Councilor Daniels reminded everyone that he and the Mayor had testified at the Legislature to get Canby in the position to withdraw from TriMet. Towns could only withdraw from TriMet if under the 10,000 population and since Canby had exceeded that, Sandy and Canby were granted a one-time opportunity to withdraw, so this is the City's only chance. TriMet is very receptive to our withdrawing and will work with us. The equipment up and moving will be the important factor.

Councilor Carson stated that they were planning on having the basic bus routes set up before the August 2001 date, so it will be the capital equipment that they will be waiting on.

Mayor Taylor expressed how impressed he has been with everyone who has been working on this project. They are all volunteers and a big thanks to all of them who are donating their time.

Discussion of Planning Commission Appointments - Mayor Taylor explained that there are three

reappointments whose terms expire at the end of December and one that will be available in January when Planning Commissioner Teresa Blackwell assumes her position on the City Council. There have been four applications submitted and the three current Commissioners have all reapplied for the positions and a fourth application has been submitted. The choices are to make appointments to the three seats tonight, or the new Council to make all of the appointments after January 3, 2001.

Councilor Strong suggested that anyone interested in applying for the Planning Commission position that will become available in January to contact City Hall for an application.

****Councilor Lucas moved to reappoint Jean Tallman, Geoff Manley and Paul Thalhofer to new three year terms on the Planning Commission and consideration be given when the new Council takes office and a vacancy occurs by that move in the Planning Commission. Motion seconded by Councilor Daniels and passed 6-0.**

Appointments to Budget Committee - Mayor Taylor said that two applications had been received by the time the packet was sent out. Since that time, there have been three more applications received. One of the positions is a new three year term unfilled since July, 2000 and the other is another vacant position which expires in July of 2001.

Councilor Prince felt that it would be appropriate since there are now five applications that the process should be left open for the new Council. There could be more applications coming and it would give an opportunity to interview. The positions have not been formally closed.

****Councilor Prince moved to table the Budget Committee appointments until a date in the future. Motion seconded by Councilor Strong and failed 3-2 with Councilors Lucas, Daniels and Carson opposed. Councilor Harris abstained.**

Councilor Carson felt there were qualified applicants now and there was no reason to table the appointments. Budget meetings would be starting early in January and it would be helpful to have the committee filled and ready to go.

Councilor Daniels felt that these positions have been advertised and open since last July. Two people came forward and their November 19th applications appear in the packet tonight; they are qualified individuals. He felt these appointments were an obligation of the current Council since these positions expired during this Council's term. Applications are immediately put into the closest packet when they are received by City Hall.

Councilor Lucas felt they should go ahead with the appointments as both applicants were well qualified.

Councilor Strong questioned whether Roger Harris could be appointed before he left office. The other three applicants should not be disqualified just because they turned in their applications after the packet went out. All the applicants should be given equal consideration. She stated that these appointments should be made by the new Council. It would be to the Council's benefit to

interview all of the five candidates, to perhaps form a subcommittee and have interviews and come to Council with recommendations.

Attorney John Kelley stated that Roger Harris could be prospectively appointed at this time to take office on January 4, 2001 which would be the day after he left office on the City Council.

Councilor Harris said that his intent had been to see that this committee was fully staffed before his term ended and since no other applicants had come forward, he had applied. He felt that all of the applicants were excellent and that this is going to be the best Budget Committee he has seen in the years he has served.

****Councilor Daniels moved to appoint Roger Harris and Harry LeeKwai with Roger Harris taking his appointment on January 4, 2001 following the expiration of his City Council term. Motion seconded by Councilor Lucas and passed 3-2 with Councilors Strong and Prince opposed. Councilor Harris abstained.**

Councilor Daniels felt that these appointments were an obligation of this Council and important to get them on board soon since the budget process is about to start.

Councilor Strong raised the opposition that there were three other applicants who are being disregarded. Packets go out a week prior to the meeting and their applications should be considered regardless of not making it in time for the packet.

Councilor Lucas felt that there needs to be an end to accepting applications otherwise applications could continue to come in and a decision would continue to be put off. These two applicants are qualified.

Councilor Prince expressed disappointment with the decision and felt that this should be the decision of the new Council since they will have to be working with the Budget Committee.

Councilor Carson felt that there is an advantage to have Budget members with experience and that the two people nominated are qualified. It will be to the new Council's advantage to have experienced Budget members.

Councilor Strong added that all five of the applicants should have a chance to be given consideration.

Attorney John Kelley wanted to clarify that the appointment of Roger Harris is to begin January 4, 2001.

Councilor Walt Daniels recommended that Harry LeeKwai serve the three year term running until July 2003 and Roger Harris serve the six month term ending July 2001. Councilors Carson and Lucas were in agreement with Councilor Daniels and Councilors Prince, Harris, and Strong chose to abstain.

ORDINANCES & RESOLUTIONS:

Ordinance No. 1061 -

****Councilor Prince moved to adopt Ordinance 1061 with omission of Section 16.100.045 Subsection 2 text “at least 51%”, AN ORDINANCE RELATING TO HISTORIC PRESERVATION, AMENDING CANBY’S COMPREHENSIVE PLAN AND TITLE 16 OF THE CANBY MUNICIPAL CODE be posted and come up for final reading on December 20, 2000. Motion seconded by Councilor Harris and passed 6-0 on first reading.**

Planning Director John Williams explained this is the first code and comprehensive plan amendment coming before them under the periodic review process. This amendment had a December 31, 2000 deadline and these changes will remove outdated text and bring Canby into compliance for State and Federal grant money. He also noted that there are no potential Measure 7 implications. With this passage, there will be the potential for funding for historic preservation activities in Canby.

Councilor Carson asked to explain the difference between historic designation and historic district and how you would get on or off either one. The wording was reviewed and the text “at least 51%” in Section 16.110.045 subsection 2 was eliminated to keep the document in conformance with State law.

Ordinance 1063 -

**** Councilor Daniels moved to adopt the amended Ordinance 1063, AN ORDINANCE AMENDING THE TITLE 1 OF THE CANBY MUNICIPAL CODE BY ADDING A NEW CHAPTER, 1.20, ADOPTING A PROCEDURE FOR PROCESSING CLAIMS MADE PURSUANT TO ARTICLE 1, SECTION 18 OF THE OREGON CONSTITUTION AS AMENDED BY INITIATIVE MEASURE 7; AND DECLARING AN EMERGENCY be posted and come up for final reading on December 20, 2000. Motion seconded by Councilor Lucas and passed 5-1 on first reading with Councilor Prince opposed.**

Mayor Taylor announced that an appeal filed in Salem has resulted in an injunction to stop the implementation of Measure 7.

Councilor Harris indicated that the injunction could allow more time to work on refining the Ordinance.

Attorney Kelley said the effect of the preliminary injunction just placed on Measure 7 prohibits the measure from becoming law. There will then be a hearing on a permanent injunction so at this time the City does not have to meet the December 7th dead line to pass an ordinance. There would be no risk in allowing more time to prepare or refine our ordinance.

Councilor Carson felt it was safer to pass this ordinance tonight in case the preliminary injunction were overturned, and then refine later, if necessary.

Attorney Kelley responded that he is not unhappy with the Ordinance before them now and as he reviews copies of new ordinances from other jurisdictions, it is clear that there is no model ordinance. Planning Director Williams has prepared an application form which conforms with the ordinance. There has still not been an Attorney General's opinion handed down; it is anticipated soon.

In response to Councilor Prince, Mr. Kelley said even if the ordinance were passed, there would be no basis for a claim under Measure 7. Councilor Prince would prefer to have the ordinance on the books now.

Councilor Daniels agreed that at this time, this ordinance is our best attempt to arrive at the ordinance; it is workable and can be amended later.

Councilor Harris feels that this is a good ordinance but his one concern is that if a claim is allowed, then the application fee should be returned.

Councilor Carson looked at the application fee as a fund to compensate staff for their time researching the claim and thought that it was a necessary expense.

Councilor Prince also thought of it as taxpayers' money to look at a claim and it would reimburse those taxpayer's for that research expense.

Councilor Lucas was in agreement with Councilor Prince.

****Councilor Harris moved to amend the motion of the proposed Ordinance 1063 to reflect wording that would allow reimbursement of the application fee if the applicant is entitled to compensation and to come up for second reading on December 20, 2000. Motion seconded by Councilor Strong and passed 4-3 with Councilors Prince, Lucas and Carson opposed.**

Mayor Taylor reiterated his vote had been cast because the overriding principle is that of fairness. If an applicant was found to be justified in his/her action, then the process should be that the application fee is returned and the applicant not damaged

Resolution 742 -

****Councilor Daniels moved to adopt Resolution 742, A RESOLUTION ACCEPTING THE RESULTS OF NOVEMBER 7, 2000 ELECTION, PROCLAIMING ANNEXATION INTO THE CITY OF CANBY OF 1.7 ACRES OF PROPERTY, AND SETTING THE BOUNDARIES OF THE PROPERTY TO BE INCLUDED WITHIN THE CITY LIMITS. Motion seconded by Councilor Strong and passed 6-0.**

UNFINISHED BUSINESS:

MANAGERS' REPORT: City Administrator Mark Adcock asked the Council to review the

application for the Hometown Hero Award for Bob Trappe.

****Councilor Lucas moved to accept the Hometown Hero Award Application for Bob Trappe and present him with the Certificate of Appreciation on December 20, 2000. Seconded by Walt Daniels and passed 6-0.**

Recreation Services Director Beth Saul reported that Georgia Pacific has contacted the City and offered a \$2,000 donation to the Parks Department to help with the wetlands restoration that she and Project Planner Matilda Deas have been working on as a grant-funded project.

COUNCILORS' ISSUES:

Councilor Carson introduced Chamber Director Bev Doolittle to show the Council the new Chamber Christmas ornament displaying the 1912 Behr House. It is available at local Chamber member businesses and sells for \$7. The past years' ornaments are available also at the Chamber office for \$5. The money collected is used to fund the Chamber of Commerce.

He also mentioned that Canby Utility should be contacted to assure that there will be power at Pioneer Plaza for a tree next year.

Councilor Daniels- thanked all those who came out to the "biggest ever" tree lighting ceremony at Wait Park.

Mayor Taylor acknowledged the Planning Commission for their many hours of dedicated service. Although he will not be able to be present at the appreciation dinner, Council President Daniels will be on hand.

Mayor Taylor also notified the Council that the Fire District has chosen not to meet with Council President Daniels and himself. The Fire District has decided to wait and meet with the new Council and see what can be worked out with them. The Mayor expressed disappointment in that action and had hoped to have some meaningful dialog to hand off to the next Council.
