Mayor Taylor called the session to order at 6:05 p.m.

The Council discussed the aesthetic components to downtown revitalization.

Mayor Taylor adjourned the session at 7:20 p.m.

CANBY CITY COUNCIL REGULAR SESSION NOVEMBER 17, 1999

Mayor Scott Taylor presiding. Council members present Barry Lucas, Roger Harris, Terry Prince, Walt Daniels, and Shirley Strong. Councilor Randy Carson absent.

Also present: City Administrator Mark Adcock, Recreation Services Director Beth Saul, Community Development Director Jerry Pineau, City Attorney John Kelley, City Planner Jason Kruckeberg, Fire Chief Ted Kunze, Fire Marshall Ron Yarbrough, Kathy Henderson, Shawn Carroll, Sidney Milesse, Steven Amick, Buzz and Pat Weygandt, Craig Lewelling, Allen Patterson, Ray Hoen, Matt Grady with Gramor, Leighton Perkins, Terry Tolls, Bob Trappe, Craig Finden, Phil Parsons, John Dewar, Lisa Weygandt, Bob Zimmer, and Curtis and Lila Gottman.

Mayor Taylor called the session to order at 7:33 p.m., followed by the opening ceremonies.

CITIZEN INPUT ON NON-AGENDA ITEMS: None.

CONSENT AGENDA: **Councilor Daniels moved to adopt the consent agenda: minutes of the regular meeting, November 3, 1999; and accounts payable in the amount of \$237,835.93. Motion seconded by Councilor Prince, and passed 5-0.

PUBLIC TESTIMONY: <u>Canby Urban Renewal Plan</u> - Mayor Taylor said at the last Council meeting they received a variety of testimony and the Council had the first reading of the Ordinance that implemented the Urban Renewal District. At that time they also set as the vote

date November 24. This was the second night they were setting aside time for people who would like to provide the Council testimony on the Urban Renewal District. He asked that if someone had already provided testimony, they not provide that again. This was for fresh perspective. Mayor Taylor gave those who wanted to testify 5 minutes to speak.

Mayor Taylor opened the public testimony at 7:37 p.m.

Ted Kunze, Canby Fire Chief, thanked the Mayor and Council for the opportunity to speak that night. The Canby Fire District No. 62 was not opposed to Urban Renewal, but they were concerned about their ability to maintain their current level of services, providing services to the Industrial Park, and a parody amongst the taxing entities. Under the normal property tax system, the Fire District received an increase of tax revenues as the adjusted market value of the district increased. Under tax increment financing, the funds went to the Urban Renewal District, and even though they were credited to a Fire Protection line item, they could not be used unless the project had a direct benefit to the Urban Renewal District. Because of that, they could not hire more personnel, and any project they would bring forward likely could not be 100% funded through the Urban Renewal District and would require participation by regular district tax revenue. Another issue was how the Fire District was different from the City. The City had more flexibility on how it apportioned out its revenue, but the opposite was true for the Fire District. They lost their ability to apply their revenues as they needed, but they also lost any additional funding towards personnel. It was mentioned that many cities in the area were using Urban Renewal districts successfully, and he agreed that they did an excellent job in shaping their communities. Most of those jurisdictions were cities with city Fire Departments. The Urban Renewal District created more money for cities, not Fire Districts. He gave examples of Wilsonville and Sandy and how Urban Renewal affected them. The issues at hand were parody and levels of service. 80% of the Fire District's tax dollars came from property taxes, and that was the very source that tax increment financing affected for them. Services offered by the Fire District would be negatively affected for the life of the plan. He gave an example of Clackamas County Fire District No. 1 and how they lost a lot of money through Urban Renewal. Chief Kunze read the Canby Fire District mission statement. He thought the Urban Renewal plan would impact their ability to fulfill their mission statement.

Councilor Harris said they had discussed arranging an IGA that was well negotiated and could satisfy the needs of the Fire District. He thought it was hard to image that they, or any elected body, would allow industrial development that was not commensurate with fire protection. He was supporting this District and he thought they could work out an agreement that would satisfy their needs and accomplish what needed to be done. Chief Kunze said one of the issues was right now when they received tax dollars, they decided where that money would go, but with Urban Renewal, they had a set of dollars that came from a specific area and could only be used for certain projects. One of the biggest things they were facing was a lack of personnel, especially during the daytime hours, and they could not use Urban Renewal dollars for that.

Councilor Prince said he understood Chief Kunze's problem, this did not allow for personnel

increases. It captured all the money, and all the money went to projects. He thought it would hurt the City in the long run as well. He said the tragedy of this was not everyone would benefit from it.

Mayor Taylor said he was sorry the Fire District was still at this place, and they would continue to work with them and to find a way to get them a comfort zone. He wanted to know how many people they could buy for \$24,000 for an area that would be industrial buildings and they would still get full funding from residential dwellings. For the amount they could buy through this process and if they managed their budget, with City help to provide money to offset the costs, this should not cause alarm. They were only taking \$24,000 out of their budget starting in 2001. Chief Kunze said they were not talking about dollars, they were talking about their ability to provide service to that area. \$24,000 was half a fire fighter, but if you looked at five, fifteen, twenty years down the road, they became relatively significant numbers.

Ray Hoen, resident of 309 SE First, Canby, appreciated the opportunity to hear the Fire Chief, representing a large district and a large budget. His district consisted of his family. He lived outside the city limits, but owned property within the city limits. He thought the Urban Renewal plan would do nothing but great things for Canby. One of the comments recently made was that the people should have a vote on this, annexations were voted on and he felt that covered it. He was also glad to see capital improvements like Township being done that would make Canby better. Just to represent one little family, he supported Urban Renewal.

Mayor Taylor closed the public testimony at 7:50 p.m.

Jerry Pineau said the Council had been given potential changes to the Urban Renewal Plan, and if they were going to make any amendments to the plan as presented, the Council needed to make a motion to change the plan that night so they could have that available to them before the final vote.

The Council discussed the two suggested footnotes that would be added to the report on the Canby Urban Renewal Plan.

**Councilor Daniels moved to add the following footnotes to the report on the Urban Renewal plan: 1. The Urban Renewal District Fire Protection project estimated cost of \$2,750,000 is the Present Value of the estimated revenues "foregone" of \$5,000,000 by the Canby Fire District No. 62, at a discount rate of 5 percent per year over the estimated urban renewal district term of twenty years; and 2. The School/City/Community Joint Use Facility project contemplates the inclusion of Clackamas Community College in the facility. Motion seconded by Councilor Lucas, and passed 5-0.

PUBLIC HEARING: First Avenue Street Vacation -

Mayor Taylor opened the public hearing at 8:03 p.m.

Page 3 - November 17, 1999

STAFF REPORT: Jason Kruckeberg said this was SV 99-01, a street vacation of First Avenue in the Industrial Area. Gramor was the petitioner on this vacation. The process was that anyone could request a street vacation, then the Planning Department sent notice to the paper and the Council requested they send notices to the property owners in the Industrial Area Association which they did. This was an area starting south of the Farm Store along Highway 99E across to where Redwood Street would become Sequoia Parkway. The Council had to hear any objections, and they received no written objections. They supplied the notice as required, and the Council's role was to see if public interest would be prejudiced by this street vacation. What the vacation would do was facilitate the development of Sequoia Parkway and the development of adjacent parcels, one belonging to Irene Burden and also the Gramor site. Along with the petition, there were four letters of support. By Statute, 66% of the affected property owners needed to be in agreement with the petition, and in this case 70% were in agreement.

There was no public testimony.

DISCUSSION: Councilor Lucas said when they first discussed the Gramor/Fred Meyer development, First Avenue was a huge issue, because people were worried about how they were going to get their trucks down to their property. Since they did not get any letters and no one testified, it appeared that everyone was satisfied. Jason Kruckeberg said they just had a meeting about the turning radius onto First Avenue, and the access from the new re-routing of First Avenue onto Sequoia Parkway. That was still an ongoing issue.

Mayor Taylor closed the public hearing at 8:10 p.m.

Mayor Taylor moved to Ordinance No. 1041.

Ordinance No. 1041 -

**Councilor Daniels moved to adopt Ordinance 1041, AN ORDINANCE VACATING A PORTION OF THE PUBLIC RIGHT OF WAY KNOWN AS SOUTHEAST FIRST AVENUE FOR STREET CONSTRUCTION AND DEVELOPMENT PURPOSES AND DECLARING AN EMERGENCY be posted and come up for final reading on December 1, 1999. Motion seconded by Councilor Lucas and passed 5-0 on first reading.

COMMUNICATIONS: Mayor Taylor said he was recently at the League of Oregon Cities annual meeting, and one of the issues they dealt with was Y2K and he thought they might not have communicated effectively with all the citizens regarding Y2K. A variety of providers throughout the Canby area had been meeting for over a year, working on what to do, what backups they would have, etc. There would be an Emergency Response Center set up and the Police Department would be manning that. They had all of the computers in the City replaced or upgraded, as well as the systems run by computers. Regarding 911 services, if there was any disruption into the center in Oregon City, the City of Canby was able to answer those emergency calls. Regarding electricity, the City and Fire District had a list of those that required emergency

power for life support systems and they had available several generators for short term emergency power. The Canby Utility Board assured them that all of the computer operating systems that controlled the distribution of electricity were compliant and these systems were Bonneville Power. CUB also had a water system that would operate at a level that would accommodate fire protection needs for minimum pressure and the available drinking water that would last for one day under normal circumstances could last up to three days. The telephone company advised that the phones would work as usual, but one thing that may stress the system was the excessive use due to the number of calls that may occur. The grocery stores indicated that their suppliers would be able to store the food and keep the stores in operation as usual. Police and fire would be fully staffed with off-duty personnel on call. Regarding gasoline and other fuels, the service stations in the area expected to operate as usual and oil companies stated they did not see any delivery problems. All major banks advised they would be in full operation except for the holidays when they were normally closed. They had the Chief of Police and a number of others working on this for quite some time to make sure they had a plan to take care of any unforseen incidents. They did have a plan to take care of any natural disasters or emergencies. The City should be running fine and at least in capable hands if anything should go wrong.

NEW BUSINESS: Reappointments to the Planning Commission - Councilor Lucas said he spoke to a lot of citizens about the openings on the Planning Commission as well as to the Leadership Canby group and there were 6 to 8 people who had picked up applications. He wanted to set the reappointments aside until the December 15 meeting to allow those people to turn in their applications. Mayor Taylor said the Planning Commission was one person short and they had two current Planning Commissioners whose terms were up on December 31. They had a potential of three vacancies.

**Councilor Lucas moved to set over appointments to the Planning Commission until December 15, 1999. Motion seconded by Councilor Harris.

Councilor Prince, as liaison to the Planning Commission, thought it would be a good idea to at least go through the applications and review them and come back with a recommendation to the Council.

Mayor Taylor said in the past, they had two Councilors and the Planning Commission Chair review the applications. Mayor Taylor, Councilor Lucas, Councilor Prince, and Planning Commission Chair Keith Stewart would interview the applicants. The Council would get to look at all of the applications.

Motion to set over the Planning Commission appointments until December 15 passed 5-0.

<u>Pioneer Plaza Reservation System for City Sponsored Community Events</u> - Mayor Taylor said this would be their process when people wanted to use the new Pioneer Plaza.

Councilor Harris said Kathy Henderson, Chamber Director, indicated there were some changes

that needed to be made to this at the outset.

Jerry Pineau said Ms. Henderson thought there was some responsibility as to the Chamber furnishing a certificate of insurance. His proposal said that the organization that was putting on the event would have to give them a certificate of insurance. The Chamber would do the scheduling, and then give all of the information to the City.

Ms. Henderson said if this document had an impact on the Chamber, her board needed to see it, and they had not had a chance to look at this. Any reference to the Chamber beyond scheduling of the lot, she needed to run by her board.

Mayor Taylor asked if there were things in this document that gave the Chamber additional duties? She said there were things that gave her additional concern. She thought she needed clarification from the two property owners and wanted to discuss her concerns with Mr. Pineau.

Mayor Taylor said there was no urgency on this. They would bring it back on December 1.

Councilor Daniels said nothing was stated about fees. Ms. Henderson said they would need a fee schedule as well. When they talked with the property owners, their goal was to make the Plaza accessible to the community. One of her concerns was the language about a certificate of insurance. If they had a group that was not part of a formal organization, did they have the resources to purchase a policy for one day. Did they want to limit the use of the lot, or did they want it open to everyone. She found some of the language was prohivative for general use of the lot if everyone were required to go through this process.

ORDINANCES & RESOLUTIONS:

Ordinance No. 1037 -

**Councilor Daniels moved to adopt Ordinance 1037, AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT WITH OREGON SITEWORKS FOR CONSTRUCTION OF TOWNSHIP ROAD PHASE II AND DECLARING AN EMERGENCY. Motion seconded by Councilor Strong, and passed by roll call vote, 5-0.

Ordinance No. 1038 -

**Councilor Lucas moved to adopt Ordinance 1038, AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH WALKER-MACY FOR PROFESSIONAL SERVICES FOR THE DESIGN OF PROPOSED PUBLIC IMPROVEMENTS TO THE THIRTEENTH AVENUE PARK/ACKERMAN SCHOOL COMPLEX AND DECLARING AN EMERGENCY. Motion seconded by Councilor Harris, and passed by roll call vote, 5-0.

Ordinance No. 1040 -

**Councilor Prince moved to adopt Ordinance 1040, AN ORDINANCE EXTENDING THE CURRENT NON-EXCLUSIVE FRANCHISE AGREEMENT BETWEEN THE CITY OF CANBY AND CANBY TELEPHONE ASSOCIATION FOR THE PROVISION OF TELECOMMUNICATION SERVICES AND DECLARING AN EMERGENCY. Motion seconded by Councilor Strong, and passed by roll call vote, 5-0.

Resolution No. 720 -

**Councilor Harris moved to adopt Resolution 720, A RESOLUTION ACCEPTING THE RESULTS OF NOVEMBER 2, 1999 ELECTION, PROCLAIMING ANNEXATION INTO THE CITY OF CANBY OF 1.45 ACRES OF PROPERTY, AND SETTING THE BOUNDARIES OF THE PROPERTY TO BE INCLUDED WITHIN THE CITY LIMITS. Motion seconded by Councilor Strong.

Councilor Daniels said they finally received the results of the vote, and it was 1,501 to 796 in favor of the annexation.

The motion to adopt Resolution 720 passed 5-0.

Resolution No. 721 -

**Councilor Harris moved to adopt Resolution 721, A RESOLUTION ACCEPTING THE RESULTS OF NOVEMBER 2, 1999 ELECTION PROCLAIMING ANNEXATION INTO THE CITY OF CANBY OF 1.44 ACRES OF PROPERTY, AND SETTING THE BOUNDARIES OF THE PROPERTY TO BE INCLUDED WITHIN THE CITY LIMITS. Motion seconded by Councilor Strong.

Councilor Daniels said the results of this vote were 1,389 to 903 in favor of the annexation.

The motion to adopt Resolution 721 passed 5-0.

UNFINISHED BUSINESS: None.

MANAGER'S REPORT: Mark Adcock said he recently went to the League of Oregon Cities annual conference. The Mayor, City Attorney John Kelley, and he attended and it was one of the best they ever had. He hoped next year more folks could attend since it was going to be held locally. He participated in discussions regarding improving communications in building community partnerships, financial matters, etc.

He was on the Logging Road that day inspecting the bridge, and he was sorry to report that some

of the area they painted over a few Sundays ago needed to be painted again. He asked the Police Chief to implement some bicycle patrols as well as an increased presence of police vehicles there. They hoped to catch the people who were doing it and they would step up their visible and covert patrols. Also, the Sargent's selection process was underway. They hoped to complete that this week and have all the candidates interviewed and make an appointment next week.

Mayor Taylor said they had a program where citizens could sign up for panels on the Logging Road bridge and the City would provide them paint and materials and they could paint the panels when they needed it. It took about 5 minutes to paint each panel. He also said there was graffiti under the Shimadzu bridge that needed to be repainted. If anyone was interested in the program, contact City Hall.

COUNCILORS' ISSUES: Councilor Lucas said the Canby Business Revitalization group wanted a liaison from the Council.

**Councilor Lucas moved to nominate Councilor Harris as the CBR group liaison. Motion seconded by Councilor Prince.

Councilor Harris said it was important to have a liaison to that organization and he would like to be involved in that. He appreciated the nomination.

The motion to nominate Councilor Harris as CBR liaison passed 5-0.

Councilor Daniels said he was up in Seattle this summer and they had a bridge with artwork that kids from the grade school painted on the panels. If they looked at the experience they had with the restrooms when they were painted, they had very little graffiti. Maybe if they did something like that on the Logging Road bridge, it may deter the graffiti there. Mayor Taylor said in Tualatin, they were working on a legal graffiti wall where certain things were allowed to be painted there and elsewhere it was cracked down on. Councilor Lucas said the Parks & Recreation board had been talking about this issue too, but had not come up with a recommendation for it yet. Mayor Taylor said Mark Adcock, City Administrator, was looking into some "magic" paint that made graffiti hard to stick to the paint. Beth Saul said they looked into that paint a couple of years ago, and it did not work as well as they thought. However, they were improving it all the time and they were applying it to a place where it might work better than where they tried it before. They would look into it again.

<u>Mayor Taylor</u> encouraged the Council to go to the League of Oregon Cities conference next year. They had a variety of excellent workshops and provided good information. Councilor Daniels said he had been to several of the conferences and the workshops were very beneficial.

<u>Mayor Taylor</u> said they would be hosting the Clackamas Cities Association meeting in January. The agenda they were putting together was using the voting record on City issues for the legislators that represented cities in Clackamas County, the legislators would talk about their

votes on city-based issues. They already had Canby's two legislators lined up to be there.

<u>Councilor Strong</u> said there was a beautification project going on at the south end of town. She thought it was looking very nice.

ACTION REVIEW:

- 1. Approving the footnotes to the Urban Renewal plan and bringing back the amendments to their special meeting on November 24 for a final vote.
- 2. Bringing back Ordinance 1041 for second reading to the December 1 meeting.
- 3. Setting aside appointments to the Planning Commission until December 15 meeting and making sure all the Council reviews the applications.
- 4. Bringing back Pioneer Plaza reservations system to the December 1 meeting.
- 5. Implementing Ordinances 1037, 1038, and 1040.
- 6. Implementing Resolutions 720 and 721.

Councilor Prince said since they looked at the downtown bike project, and talked about it as being a temporary project, and had looked at a new scheme that did not include bike lanes downtown, he wanted to remove the stripes before the holiday traffic came downtown. Mayor Taylor said he did not know if they had acted on that proposal. Ms. Gottman said they had not.

Councilor Prince said he assumed it was only temporary. Councilor Lucas said they were put in temporarily, and since it was the recommendation of the Bike & Pedestrian Committee to have them removed, and they had a lot of public testimony that citizens wanted them to be removed, he thought they should be removed. Councilor Strong agreed. Councilor Daniels agreed with removing them, but one of the reasons they got into this discussion was they were trying to get bicycles off the sidewalks. What were they going to do about keeping bicycles off the sidewalks?

Mayor Taylor said they decided the bikes would be on the roads. Councilor Harris said they had not resolved the issue, but it was very hazardous to have the bike lanes behind diagonal parking, especially now that it was getting dark early. It seemed that the consensus was for them to be removed, and it was better to take them out sooner than later. Mayor Taylor said the question was should they get rid of them now? He thought the Council was in agreement to take them out now. The recommendation would remove the bike lanes on two blocks.

**Councilor Prince moved to instruct staff to remove the bike lanes between First and Third streets on N. Grant at the soonest time available weather permitting, but not to be allowed to go into the holiday season. Motion seconded by Harris.

Jerry Pineau said they had not yet put the bike lanes in past the railroad tracks on Grant to continue across 99E to the other side of town. Did the Council want those lanes put in now they had the permit? The Council just wanted to remove the bike lanes for now. Councilor Strong wanted to make sure they would be removed on both sides of the street.

Councilor Lucas said it was the decision of the Bike & Pedestrian Committee that people could still ride bikes downtown, but because of the diagonal parking and other safety issues, they would not have people ride on the sidewalks, but to have them in the street, and not to have bike lanes in the downtown core area.

The motion to remove bike lanes between First and Third on N. Grant passed 5-0.

Councilor Daniels said they had talked with the Police Chief and the Traffic Safety Committee about safety programs for bicycles and having twice a year a bike rodeo, which would give kids information on bicycle safety.

**Councilor Daniels moved to go into Executive Session under ORS 192.660 1(d) labor negotiations. Motion seconded by Councilor Prince, and passed 5-0.

Mayor Taylor said the Council would only discuss one issue at the special meeting on November 24, and the meeting would only be as long as it took the Council to debate the issue. The Council decided to meet at 6:30 p.m.

Mayor Taylor recessed the regular session at 9 p.m.

Mayor Taylor reconvened the regular session and immediately adjourned the session at 11:25 p.m.


