Councilmembers present: Mayor Pulver, Councilmembers Anderson, Brennan Jordan, Sowles and Taylor. Absent Councilwoman Kopelk.

Also present were Budget members Knight, Brown and Schultz. City Administrator Bud Atwood, Librarian Beth Saul, Police Chief Jerry Giger, City Treasurer Virginia Graham, Scott Wiesehan and Peggy Wickwire.

Mayor Pulver opened the Special Meeting at 7:00 p.m. followed by the flag salute.

Councilman Jordan thought attendance very important and members should be talked to.

Mayor Pulver commented the Commission is pleased the way things are running and Mr. Shinn missed so many meetings because of college classes. All three nominees are good, but there are only two openings. Mayor Pulver asked for a vote by show of hands.
