CANBY CITY COUNCIL SPECIAL MEETING MAY 12, 1982

Mayor Robert A. Swayze presiding. Councilmembers present: David Anderson, Lee Funrue, Beryl Brown, Mike Gabrion, Bill Pulver and Gary Sowles.

Also present, Acting City Administrator Robert E. Rapp, Bud Atwood Public Works Supervisor, Myra Weston Treasurer, Marilyn Perkett Recorder Pro Tem, David Bury, Charter Revision Committee Members Stephan Lashbrook, Jim Renner, Chip Phelps and Earl Oliver.

Mayor Swayze called the special meeting to order at 7:32 p.m., followed by the flag salute and silent meditation. Roll call of Council showed a quorum.

BUSSINESS TO COME BEFORE THE COUNCIL: Mayor Swayze read by title only for second reading, Ordinance No. 718. **Councilman Sowles moved that Ordinance 718, AN ORDINANCE AUTHORIZING CONTRACT FOR PURCHASE OF PRIMARY CLARIFIER-THICKENER MECH-ANISM FROM EIMCO DIVISION OF ENVIROTECH FOR SEWAGE TREATMENT PLANT be approved and become part of the laws of the City of Canby. Seconded by Councilman Pulver and approved 6-0 by roll call vote.

Administrator Rapp read Ordinance No. 723 in full for first reading. **Councilwoman Funrue moved that Ordinance 723, AN ORDINANCE AUTHORIZING AWARD OF CONSTRUC-TION CONTRACT NO. 2 TO LORENTZ BRUUN COMPANY FOR PHASE I EXPANSION OF SEWAGE TREATMENT PLANT; AND DECLARING AN EMERGENCY be posted and come up for final reading at the regular meeting set for Tuesday, June 1, 1982, after 7:30 p.m. Seconded by Councilman Pulver and approved uanimously.

Administrator Rapp read a memo from Dan DeRego, Swim Center Manager, requesting permission to change the admission rate for adult swim sessions from 75¢ to \$1.00, the rate has not been changed in 12 years. Mr. Rapp explained that the adult swim sessions would be extended from 45 minutes to one hour. Councilman Gabrion is a frequent patron of the swim pool and felt the request was valid. **Councilman Gabrion moved to grant the request to increase the admission rate for adult swim from 75¢ to \$1.00, and increase the session from 45 minutes to one hour, to become effective June 1, 1982. Seconded by Councilman Anderson and approved 6-0.

Mayor Swayze called for a short recess at 7:46 p.m. before going into workshop session on the City Charter Revisions.

Mayor Swayze reconvened the special meeting at 9:16 p.m. Councilman Anderson questioned if any information was available on CATV. Mayor Swayze noted that Mr. Page, Cable TV Consultant is working on documents and a workshop will be held on June 9th regarding the CATV. Mayor Swayze adjourned the special meeting at 9:17 p.m.
