SPECIAL MEETING

MARCH 10, 1980

Mayor Robert E. Rapp presiding. Councilmembers present: Beryl Brown, Beauford Knight, Bill Pulver, Richard Nichols and Robert Swayze. Absent: Robert Westcott.

Also present: Administrator H.A. Wyman, City Attorney Wade P. Bettis, Treasurer Myra Weston, City Planner Stephan Lashbrook, Public Works Director Ken Ferguson, Public Works Supervisor Bud Atwood, Secretary Marilyn Perkett, Budget Committee Members Earl Oliver and Nancy Kopelk, Canby Herald Editor Steve Fredrick, Bob Graham, Dale Mallicoat, Jim Haas, James Adair, Dr. John Harpster, Dan Hemstreet, Larry Whitman, Gordon Ross, Don Wagoner, David Bury and Mr. and Mrs. Fred Hultgren.

Mayor Rapp called the Special Meeting to order at 7:35 p.m., followed by the flag salute and roll call of Council.

Administrator Wyman read a letter from the Canby Garden Club requesting permission to plan a tree at a historical site such as the Baker Pioneer Cemetery. Mrs. Carr also noted that the Canby Historical Society may be interested in planting a tree and the other side of the entrance, therefore a tree on each side of the entrance. Councilman Swayze moved that the Canby Garden Club, through Mrs. George Carr, be allowed to plant a flowering or decorative tree at the Baker Pioneer Cemetery and to coordinate their effort with Mr. Bud Atwood and to send a thank you letter. Seconded by Councilman Knight and approved unanimously.

Mr. Wyman read a letter from Pastor Jacobson, Zoar Lutheran Church, to the Weyerhaeuser Company, thanking them for the trees they were able to plant at the Maple Street Park with the efforts of the Senior Luther League Youth Group. Mayor Rapp suggested we write a thank you letter to the Youth Group and also one to the Weyerhaeuser Aurora Tree Farm for their contribution.


Mayor Rapp recessed the Special Meeting at 7:40 p.m. to go into workshop on the Elm Street traffic problem. Willamette Green Phase II issue and tax base proposal with the Budget Committee.

Mayor Rapp reconvened the Special Meeting at 8:20 p.m. Councilman Swayze moved that a 4-way stop, with appropriate stop signs, be constructed on the corner of S.W 2nd Avenue and S. Elm Street and that a 30 foot no parking restriction be instituted on each side of the four corners on Elm Street. Seconded by Councilman Pulver and carried 4-1, with Councilman Knight voting nay.

Mayor Rapp recessed the Special Meeting at 8:32 p.m. to go into workshop on the Willamette Green Phase II issue and the proposed tax base with the Budget Committee.

The Mayor reconvened the Special Meeting at 10:04 p.m. Councilman Swayze moved that staff be instructed to proceed with the proposed tax base in the amount of \$1,713,018. Seconded by Councilman Pulver and approved 5-0.

Mayor Rapp reminded Council of the workshop on March 26, Budget Election on March 25 and the Open House at City Hall, 5:00 to 8:30 p.m. on March 24. The Special Meeting was adjourned at 10:10 p.m.

P R O C L A M A T I O N

WHEREAS, the Twentieth United States Decennial Census of Population and Housing will be conducted beginning on April 1, 1980; and

WHEREAS, all the inhabitants of the City of Canby, Oregon are to be enumerated in this census; and

WHEREAS, the information collected in the census serves many useful purposes, among which are apportionment of representation in Congress and other legislative bodies, measurement of the economic well-being of communities and their inhabitants, allotment of certain Federal and State tax revenues and other financial aid to our communities, determination of future needs for public services, and numerous other useful purposes; and

WHEREAS, the accuracy and completeness of the census for the City of Canby, Oregon will determine its population rank among other communities of the country;

NOW, THEREFORE, I, Robert E. Rapp, Mayor of the City of Canby, Oregon, do hereby proclaim April 1, 1980, as CENSUS DAY in Canby, Oregon, and do urge and implore all residents to cooperate fully during the month of April with those who are charged with the responsibility of this most important work.
