## Canby City Council Regular Meeting April 18, 1979

Mayor Robert E. Rapp presiding. Present: Councilmembers Beryl Brown, Beauford Knight, Richard Nichols, Robert Swayze, Leonard Taylor and Robert Westcott.

Also present: Treasurer Myra Weston, Attorney Wade P. Bettis, City Planner Stephan Lashbrook, Secretary Marilyn Perkett, Utility Board Manager Fred Egger, Canby Utility Board Members Dennis Nolder and Howard Barlow, Oregonian Reporter Dianna Schmid, Canby Herald Editor Paul Borsage, Chairman of Canby High School Board Dr. Michael Harms, Superintendent of Canby High School Richard Brown, Mark P. O'Donnell, Martin Clark, David Bury, Ronald E. Johnson, Harry Seabold, Gary Sowles, Maynard Nofziger and Don Smith.

Meeting was called to order at 7:30 p.m.,flag salute and roll call. Minutes of Special Meeting March 29, 1979 and Regular Meeting April 4, 1979, were approved with the following addition to March 29, 1979 minutes: Paragraph 4 after "replying" - Mr. Rorabeck said the Bank of California might have reservations on subletting of the building, but would not unreasonably withhold the privilege. Mr. Bettis said that most lease agreements do not allow for subletting. Motion by Councilman Knight, seconded by Councilman Westcott, approved 6-0.

On non-agenda items, Superintendent Brown of Canby High School requested support from the city for services on an unidentified proposed site for future building. Proposed site to be a minimum of 1,000 yards outside of city limits. Staff will set up a workshop to persue this matter.

Mayor Rapp presented Attorney Wade P. Bettis with an honorary "Citizen Award" plaque for his participation in assisting Mrs. Pataki on November 14, 1978. Mr. Steve Coffman was not present to receive his award, it will be mailed.

Public Hearing on Appeal for McLeod Variance has been rescheduled for May 2, 1979, due to lack of proper public notice.

Mr. Lashbrook read a letter from the Planning Commission on Conversion of Apartments to Condominiums. Councilman Swayze moved to accept recommendation of the Planning Commission to approve no further conversions until an ordinance has been prepared by the City Planner and City Attorney for review and public hearing before the City Council. Councilman Taylor seconded, approved 5-0 with Councilman Nichols abstaining due to conflict of interest.

Planner Lashbrook read a letter on his concern of City Housing Policies, with recommendation to have a workshop with County Housing Authority and MSD. Mr. Knight expressed concern on involving the MSD. Attorney Bettis advised to meet with MSD to "listen". Mayor Rapp expressed desire to meet with them, commenting, "Well, they can't out weigh me!" Councilman Westcott moved to accept this recommendation of the City Planner. Councilwoman Brown seconded. Roll call vote, yea Brown, Knight, Nichols and Taylor; nay, Swayze and Westcott, passed 4-2.

April 18, 1979

A letter of resignation from the City Budget Committee was read from Marilyn Perkett. Councilman Nichols moved to accept the letter and write a thank you in return, Councilman Knight seconded, approved 6-0.

A letter from Mr. Egger was presented concerning purchase of 23.4 acres of Mc-Maugh property for additional water source, with deadline for decision to be April 19, 1979, or property and proposal to be withdrawn. After Council discussion, Councilman Nichols moved to purchase the McMaugh property for \$107,500., with the method of financing to be other than water bond money. Seconded by Brown, roll call vote, yea, Brown, Nichols, Swayze; voting nay, Knight, Taylor Westcott. Mayor Rapp cast deciding favorable vote, approved 4-3.

Under new business, Councilman Taylor moved to approve and pay accounts payable of \$29,920.61, seconded by Swayze, approved by roll call vote 6-0. Taylor moved to pay water bond account of \$4,500, seconded by Westcott, roll call vote, 6-0.

Quotes for sewer line T.V. inspection were presented. Bids presented from Gelco Grouting Service and an updated, April 17, 1979, bid from Falkenberg Construction. Councilman Westcott moved to accept the Gelco Co. bid of \$1,500. as per agreement, Councilman Swayze seconded, unanimously approved.

A letter from Professional Fire Fighters Assoc. of Clackamas County was read in recognition of Officer Kim Harris for his rescue incident of March 12, 1979. A copy to be put in Officer Harris' file.

Under unfinished business, Councilman Swayze moved to remove from the table the L.I.D. for N.W. 3rd and Baker Drive, seconded by Councilwoman Brown, approved 5-0 with Councilman Westcott abstaining due to conflict of interest. After Council discussion, Councilman Swayze moved to direct Public Works to proceed with an engineering report of costs and feasibility as per Ordinance #393, Sec. 2 for L.I.D. on N.W. 3rd and Baker Drive. Brown seconded, approved 5-0, Westcott abstaining.

Councilman Swayze moved to request engineer report on cost and feasibility for L.I.D. on N.E. Territorial, N. Locust and N. Juniper as per Ordinance #393, Sec. 2. Councilman Westcott seconded, approved 6-0. Planner Lashbrook pointed out that this L.I.D. had not been removed from the table before action was taken. Councilman Swayze moved to remove from the table the L.I.D. on N.E. Territorial, N. Locust and N. Juniper. Councilman Taylor seconded, approved 6-0. Councilman Swayze moved to re-state his motion on the L.I.D., Councilman Taylor seconded, approved unanimously.

Other reports, nominations for Planning Commission vacancy were opened. Councilman Taylor nominated Robert Weygandt, Councilwoman Brown nominated Catherine Davis, Mayor Rapp submitted Jack Howay and Howard Perkin as persons that had contacted him as interested.

Mayor Rapp recessed at 9:05 p.m. for council to review candidates. Meeting reconvened at 9:11. Vote for Planning Commission member was by raise of hands: Jack Howay - O, Howard Perkin: - 1, Catherine Davis - 3, Robert Weygandt - 2. Mrs. Catherine Davis was appointed and will be notified.

April 18, 1979

Mayor Rapp set up the following workshop dates: April 30, 1979, May 7, 1979 and May 14, 1979, all to be at 7:30 p.m. Topics for the workshops, but not on a specific date, are: High School Building Proposal, L.I.D. Ordinance, MSD and County Housing Authority and also to finalize the City Charter. Councilman Swayze stated that he will be out of town on May 14, 1979.

Mrs. Weston invited everyone to the lunchoen on May 1, 1979, of the Canby Chamber of Commerce to hear City Planner Lashbrook review the City Charter and Mr. Fred Kahut will report on the "landfill" being considered by the MSD west of Canby at the Mira Monte Farm.

Councilman Westcott moved to recess in accordance with ORS 192.610 for executive session on labor negotiations. Seconded by Councilman Swayze, approved 6-0. Recessing at 9:23 p.m. and reconvening at 9:41 p.m. and immediately adjourning.
