SPECIAL MEETING

MAY 14, 1979

Council President Robert Westcott presiding. Councilmembers Beryl Brown, Beauford Knight, Robert Swayze, Richard Nichols and Leonard Taylor.

Others present: Administrator H.A. Wyman, Planner Stephan Lashbrook, Treasurer Myra Weston, Public Works Director Ken Ferguson, Secreatary Marilyn Perkett. Also, Herb Beals of MSD, Jad Cordes and Dick Danforth from Clackamas County Housing and Community Development, Paul Borsarge Canby Herald Editor, Diana Schmid Oregonian Reporter and David Bury.

Meeting was called to order at 7:30 p.m. After flag salute and roll call, President Westcott opened the meeting to business.

Councilman Swayze read Ordinance No. 656. Swayze then moved to adopt Ordinance No. 656 Authorizing Contract for Cushion Turf and Paving for Maple Street Park Phase II and Declaring an Emergency and to be posted for second reading to be held on June 6, 1979. Councilman Taylor seconded, approved 6-0.

Councilman Swayze moved to remove from the table Resolution No. 620. Councilman Brown seconded, approved 5-1.

Councilman Swayze moved to approve Resolution No. 620 Declaring the Necessity to Take Private Property for Municipal Use; and Directing Proceedings to be Taken Under the General Laws of this State to Procure the Same. Councilman Brown seconded. Council discussion concerned tying up money for property in question. Consensus was that this Resolution did not tie up any money but kept possibilities open for negotiations. Roll call vote: Voting yea, Brown, Nichols, Swayze and Westcott; voting nay, Knight and Taylor. Approved 4-2.

President Westcott recessed at 7:43 p.m. to go into workshop session with MSD and Clackamas County Housing and Community Development. Councilman Swayze and Taylor were excused from the meeting at this time.

Special meeting was reconvened at 8:50 p.m. Councilman Knight moved to go into Executive Session on negotiations in accordance with ORS 192.610, with Blair Services. Councilman Nichols seconded, approved 4-0.

Special meeting was reconvened at 10:45 p.m. and immediately adjourned.
