

CANBY CITY COUNCIL

SPECIAL MEETING

MAY 31, 1979

Mayor Robert E. Rapp presiding. Councilmembers present: Beryl Brown, Beauford Knight, Richard Nichols, Robert Swayze, Leonard Taylor and Robert Westcott.

Others present: Administrator H.A. Wyman, Treasurer Myra Weston, Planner Stephan Lashbrook, Public Works Director Ken Ferguson, Public Works Superintendent Bud Atwood, Attorney Wade P. Bettis, Secretary Marilyn Perkett, Canby Herald Editor Paul Borsarge, Oregonian Reporter Diana Schmid, David Bury, Dorothy McCormick, George Cattley and Walter Dohrman.

Meeting was called to order at 7:31 p.m. followed by flag salute and roll call. Meeting was then opened for business.

Mr. Wyman informed Council that the core sample testing on S.W. 13th Avenue will be done by the State of Oregon for \$50.00 a core.

Mayor Rapp recessed Special Meeting at 7:33 p.m. for Public Hearing on the proposed 1979-80 City Budget.

Administrator Wyman gave a synopsis of the 1979-80 Proposed Budget, stating that based on current proposed assessed evaluation, cost per thousand to be \$3.83, which is 53¢ lower than last year.

Mayor Rapp asked if anyone from the audience wanted to speak in favor or against the proposed budget. Mr. Cattley inquired about going over the 6% limitation. Mayor Rapp, Councilman Taylor and Mr. Wyman all responded as to the inflation, rising costs, and community growth since the 1966 tax base. Mr. Dohrman inquired as to a better way to get information to voters and requested a speaker for the Loaves and Fishes on the budget. Mayor suggested Stephan Lashbrook as a speaker. Mr. Wyman presented a hand-out-sheet that was used last year and was effective. Mr. Cattley inquired about Loaves and Fishes monies in proposed budget. It was pointed out that Social Services has \$4,000.00 budgeted. Mr. Borsarge inquired if any new personnel was budgeted. Reply was one police officer and ½ time secretary in the Police Department.

Councilman Westcott and Taylor both committed on this years budget being very good.


Councilman Westcott moved to adjourn Public Hearing, Swayze seconded, unanimously approved.


Mayor Rapp adjourned Public Hearing at 7:55 p.m. and immediately reconvened the Special Meeting.

Attorney Bettis read Resolution 261. Councilman Westcott moved to adopt Resolution 261, A Resolution Adopting Budget and Calling a Budget and Tax Levy Election for Fiscal Year 1979-80. Councilman Swayze seconded, roll call vote, 6-0.

Mayor Rapp noted that the Police Department labor negotiations were slightly different since the May 30, 1979 meeting and settlement was much closer together.

Meeting was adjourned at 8:13 p.m.
