ACTION REQUESTED: That the Board vote to ratify the LTD/ATU Agreement as ratified by the

Amalgamated Transit Union, Local 757, on March 13, 2005

BACKGROUND: Lane Transit District and the Amalgamated Transit Union (ATU) have

negotiated to completion a three-year Agreement on the terms and

conditions of employment for LTD's represented employees.

LTD's objective in this bargaining process was to create a labor contract that better matched increases in personnel services costs with projected increases in revenues. The strategy included modifying the health care benefit to create cost controls while providing quality health care to employees, better matching wage increases to the Portland/Salem Consumer Price Index, retaining current retirement benefits, and addressing work rules that impact costs or management rights. We understood that the ATU's objectives were to roll over the level of

benefits and wage increases contained in the expired contract.

The negotiations lasted 10 months, and included formal mediation services provided the Oregon's Employment Relations Board. Members approved a strike that lasted seven calendar days, during which time a small group of community leaders assisted both parties to reach agreement. A tentative agreement was signed March 12. On March 13 ATU members voted to approve the agreement by a vote of 185-6. A

summary of the changes to the agreement is attached.

RESULTS OF RECOM-MENDED ACTION:

LTD will enter into the three-year labor agreement as outlined, effective

March 13, 2005.
