BACKGROUND: In preparation for strategic planning work sessions scheduled in October

and November for senior staff and Board members, an update of the eightyear financial projection has been prepared for discussion. Assumptions

used in the attached projection include the following:

A 4 percent per year growth in total personnel services

- State support of special transportation services at current levels
- Increased operating expenses associated with the opening of the new Springfield Station
- Payroll tax rate increases beginning January 1, 2005 (We will also have numbers for a January 1, 2007, implementation date for Wednesday's meeting.) New tax revenues will support operations and will not be dedicated to capital match.
- A favorable ruling in the pending tax court case
- Increased operating expenses associated with the BRT Pioneer Parkway corridor

Additional revenues or reductions in operating expenses in order to maintain adequate reserves are highlighted in orange. Under current assumptions, including the earlier start date for the payroll tax rate increase, the General Fund will need to make a net \$700,000 correction by FY 2006-07. The need rises to \$2.3 million in FY 2007-08.

Unfunded portions of the BRT project are highlighted in pink.

Also attached to this memorandum is the first draft of the Capital Improvements Program update. Additional information and materials will

be available at the October 21 meeting.
