RESOLUTION No. 16 for 1915.

Authorizing the Retirement of certain
IMPROVEMENT BONDS.

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF
LEBANON, OREGON:

That, whereas the City Treasurer has reported
that there is now in his hands, in the "Improvement Bond
Sinking Fund", derived from payments of principal on the
improvements made to Main, Sherman and Grant Streets in
the year 1913, and for which bonds were issued on the 1st
day of December, 1913; *somewhat over \$260000* therefore,

The City Treasurer is hereby authorized and di-
rected to take up, pay and cancel, on the 1st day of
June, 1915 (that being the date of the next semi-annual
coupon period on said bonds), the following mentioned
Improvement Bonds of said City, to-wit:

Improvement Bonds numbered One (1), Two (2) and
Three (3), "Series A", dated December 1st, 1913, each of
said bonds being of the denomination of \$500.00;

Improvement Bond numbered One (1), "Series B",
dated December 1st, 1913, said bond being of the denomina-
tion of \$500.00;

Improvement Bond numbered One (1), "Series C",
dated December 1st, 1913, said bond being of the denomination
of \$500.00.

And said Treasurer is further directed to give not-
ice, as required by law, of the redemption of said bonds, as
aforesaid, and that interest thereon will cease on the said
1st day of June, 1915.
