

RESOLUTION 3 FOR 1917

1  
2 INTRODUCED BY COUNCILMAN A. I. CRANDALL.

3 RESOLVED BY the common council of the City of Lebanon, Oregon  
4 that there is on file with the recorder of the city of Leba-  
5 non, Oregon, a petition for the improvement of Ash Street from  
6 the East line of Main Street to the East line of ~~Williams~~ Street  
7 and for the Improvement of Vine street from the East line of  
8 Main Street to the East line of Williams Street, and for the  
9 improvement of Williams Street from the South line of Vine  
10 Street to the North line of <sup>Grant</sup> ~~E. K.~~ street, and the improvements  
11 to be known and designated as the Ash Street District in the  
12 City of Lebanon, Oregon. The said Improvements to be in the  
13 following manner.

- 14 1.- By grading the said streets to proper sun grade.  
15 2.- By constructing proper drainage for the said streets.  
16 3.- By graveling the road way of the said streets to a width  
17 not exceeding twelve feet, and of sufficient thickness  
18 to make a thorough fare of good condition for traffic all  
19 all the year, the same to consist of not more than three  
20 courses of crushed gravel.  
21 4.- By rolling the same when spread on the said road way  
22 with a ten ton roller so that the same will be compact.

23 AND BE IT FURTHER RESOLVED by the said Council that the  
24 said council ascertained and determined from the said petition  
25 now on file in said matter with the recorder of the said City  
26 that the said petition is signed by the owners of more than a  
27 majority of all the abutting real property on each of the said  
28 streets to be so improved and by the owners of more than a  
29 majority of all the real property abutting upon or specially  
30 benefited by the said proposed improvements of the said streets  
31 as a whole District.

32 AND BE IT FURTHER RESOLVED By the said Council that the  
said petition asks and petitions that the same be made at  
one<sup>th</sup> and that No notice of the intention to make the said  
improvement be given by publication or other wise to the owners

1 of the real property abutting upon the said streets and the  
2 real property specially benefitted thereby.

3 AND BE IT FURTHER RESOLVED by the said Council that by reason  
4 of the said petition, and as provided by Article IV of the  
5 charter of the City of Lebanon, that the said city has ac-  
6 quired jurisdiction to make the said improvements as prayed  
7 for in the said petition.

8 AND BE IT FURTHER RESOLVED That the said City of Lebanon  
9 proceed at once to make the said improvement to the said  
10 streets without advertising for any bids therefor.

11 Passed by the Council this 5th day of October, 1917, by  
12 aye and nay vote on the roll call of the council.
