1 RESOLUTION NO. 18, FOR 1919

2 INTRODUCED B. L. COTTON, COUNCILMAN

4 Resolution Adopting a Budget of Expenditures for the City of
5 Lebanon, in Linn County, Oregon, for the Fiscal Year 1920, and
6 making and fixing the tax levy for said year and the amount of
7 money to be raised meet the said expenditures:

8 WHEREAS, it is necessary that funds be raised to meet the
9 expenditures of the government of the City of Lebanon, in Linn
10 County, Oregon, for the first fiscal year of 1920, and the
11 payment of the salary of city officers, and the interest on the
12 bonded indebtedness of the said City, and to pay the maturing
13 bonds of the said city and for fire protection and other general
14 expenses of the said city, including the repair of streets,
15 crosswalks and bridges and for the lighting of the streets, and

16 WHEREAS, The Common Council of the said City has adopted a
17 budget system for the said city as by law required,

18 NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL
19 OF THE CITY OF LEBANON, IN LINN COUNTY, OREGON.

20 That the following be and the same is hereby adopted as the
21 budget of expenditures for the City of Lebanon, in Linn County,
22 Oregon, for the fiscal year of 1920, and that the several amounts
23 and sums therein named shall be and are hereby appropriated for
24 the several purposes and objects therein named and specified,
25 as follows:-

AND BE IT FURTHER RESOLVED, that no officer or head of any department of the city government shall during the said fiscal year of 1920, incur or create and debt, liability or obligation on behalf of the city of Lebanon, Oregon, against any of the said accounts which in the aggregate shall exceed the amount herein appropriated for his department or office, unless the council shall first specifically authorize such additional expenditures or liability or obligation and shall have provided for the payment thereof. And

WHEREAS, It is necessary to meet the said appropriations and expenditures, and to pay the general expenses of the said City and the salary of the officers and to pay the interest of the bonds of the said city and other expenses and charges against the said city as enumerated in the said budget, and in addition to the other revenue and moneys of the said city that money be raised by general taxation on all the taxable property of the said city of Lebanon, Oregon.

1 NOW THEREFORE BE IT FURTHER RESOLVED, by the Common Council
2 of the City of Lebanon, in Linn County, Oregon, that for the
3 purpose of meeting the said expenditures of the said city of
4 Lebanon, Oregon, for the fiscal year of 1920, and to pay the
5 general expenses of the said city, and the salary of the officers
6 of the said city, and the interest on the bonded indebtedness of
7 the said city, and the repair of the streets and cross walks
8 of the said city and all other necessary expenses of the said
9 city as provided for in the said budget, and specified therein,
10 that there be and there is hereby levied upon each One Dollar
11 of the assessed valuation of all the taxable property of the
12 said City of Lebanon, Oregon, as shown by the ~~XXXXXXXXXXXX~~

14 said County now on file in the office of the assessor for the

9 And that the total amount to be levied be the said sum of
10 \$18,939.00 less the sum of \$539.00 raised by licenses and
11 other sources of income of the said city, and also ~~less~~ the
12 amount to raised by the road levy made by Linn County, Oregon.

12 AND BE IT FURTHER RESOLVED, That the recorder of the City of
13 Lebanon, Oregon, at once Notify the County assessor of Linn
14 County, Oregon, in writing of the amount of money hereby re-
15 quired to be raised by taxation by the said city for the said
16 fiscal year 1920.

17 November, 1919, by unanimous vote of all members elected to
18 the council.
