RESOLUTION NO. 29 FOR 1921.

RESOLUTION DECLARING AN ASSESSMENT FOR THE IMPROVEMENT OF WILLIAMS
STREET FROM VINE STREET NORTH TO ISABELLA STREET.

WHEREAS, on the 20th day of May 1921, there was filed with the Recorder of the City of Lebanon a petition duly signed by the owners of more than a majority of all the abutting real property and the real property specially benefitted thereby, asking that certain streets be improved, as hereinafter mentioned and described and WHEREAS, on the 20th day of May 1921, the Common Council of the City of Lebanon duly adopted and enacted a resolution requiring of the City Engineer and Superintendent of Streets of the said city, plans and specifications and estimates of the probable total cost of the making of the said improvements as asked for in the said petition and WHEREAS, on the 20th day of May1921, the said City Engineer and Superintendent of Streets of the said city filed with the recorder their plans and specifications and estimates of the probable total cost of the said improvements of the said streets as asked for, That the estimates so made of the probable total cost of the said improvements as asked for was and is the sum of \$271.26, and that the estimate of the total cost of the said improvement to be paid by by the city of Lebanon was and is the sum of \$60.00, and that the estimate of the probable total cost of the said improvement to be paid by the owners of the abutting real property and the real property specially benefitted thereby was and is the sum of \$211.26. WHEREAS, the City Engineer and Superintendent of Streets have made their report in writing and filed the same with the Recorder of the said city showing that the said improvements have been fully completed according to the said petition and the plans and specifications therefor, and that the total cost of making the said improvements is the sum of \$304.35, and that the sum to be paid by the city of Lebanon is the sum of \$92.50, and that the sum to be paid by the owners of the abutting real property and the real property specially benefitted therefor is \$211.26.

WHEREAS, The Council did on the 20th day of May 1921, duly adopt a resolution adopting and approveing the said plans and specifications and estimates of the probable total costs of the said improvement, and authorized the work to be done by the city without advertising for bids for the same as prayed for in the said petition.

WHEREAS, the reports of the said improvement as filed by the city engineer and superintendent of streets shows that the said improvements did not cost more than the said estimates, and in no case is the total cost more than the estimates against any lot or tract of land, NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, OREGON.

That the report of the City Engineer and Superintendent of Streets be and the same is hereby retified, approved and confirmed in all things. and

BE IT FURTHER RESOLVED, That the total cost of the said improvements of the said Williams Street form Vine Street North to Isabella is the sum of \$304.35, and that the portion thereof to be paid by the city of Lebanon is the sum of \$92.50, and that the portion thereof to be paid by the owners of the abutting real property and the real property specially benefitted thereby is the sum of \$211.26, and BE IR FURTHER RESOLVED, that the amount assessed to and against each separate lot and tract of land be and the same is hereby fexed as follows:

AND BE IT FURTHER RESOLVED THAT THE assessment roll summitted by the City Engineer and Superintendent of Streets and attached to their report of the improvement of the said streets be and the same is hereby adopted as the assessment roll for the improvement of the said streets and the same is in all things approved and ratified and confirmed, and the said assessments are hereby declared a lien against the several parcels and lots and tracts of hand therein described in the amounts set out therein.
