RESOLUTION NO 7 FOR 1922.

RESOLUTION AUTHORIZING THE CANCELLING OF GRANT STREET LIEN  
WHEREAS, heretofore and on the 15th day of December, 1914, the common Council of the City of Lebanon, Oregon, duly enacted and passed Ordinance No. 179, which said ordinance was duly approved by the Mayor on the said 15th day of December, 1914, and which said ordinance created and fixed liens upon and against certain real property for the improvement of East Garnt Street in said city of Lebanon, and which said lien was thereafter duly entered and docketed in the City Lien Docket of the said City of Lebanon, and among other liens the following lien was duly entered and docketed against the followingm described real property to-wit-

(1) Owned by P. M. Scroggin:

Beginning at a point distant 868.55 feet West and 256. feet North from the Southeast corner of the D.L.C. of Jeremiah Ralston and wife, Not. No. 2303 and Claim No. 49 in Tp. 12 S.R. 2 W. of the Will. Merd. in Linn County, Oregon, and running thence North 244 feet to the South side of Grant Street; thence South 86° ;5' East 441.2 feet along the South side of Grant Street; thence South 213 feet; thence West 440.25 feet to the point of beginning  
Assessment \$934.36

And Whereas, at the request and with the agreement of the said city of Lebanon, the said P. M. Scroggin deeded and conveyed to the city of Lebanon a strip of land 60 feet wide off the west side of said tract and also extended south to North line of Oak street, which strip was and is intended and used for streets purposed in the said city and being an extension of River Street north from Oak Street to Grant Street, which said deed had been accepted by the said city and duly recordd in the deed records for said Linn County, and now is used as and for a public streets of the said city.

AND WHEREAS, in consideration of the said deed the city of Lebanon agreed to assume all that port of the said lien for said improvement on the south half of said Grant street and abutting upon the end of said strip ;and used for said street, the amount of the principal thereof on said portion thereof being the sum of \$127.22 and the amount of the interest thereon to be assumed by the said city being the sum of \$60.02. and

WHEREAS THE SAID P. M. Scroggin has paid or caused to be paid all

the balance of the said lien against the said hereinbefore de-  
scribed and mentioned land.

NOW THEREFORE in consideration of the said deed and the said  
payment, Be it hereby resolved by the Council of the City of  
Lebanon, Oregon, that the recorder of the said City of Lebanon  
be and he is hereby empowered and directed to cancel and satisfy  
all and the whole of the said lien against the said above described  
land and premises, and charge to the City of Lebanon the said  
sum of the said lien against the said land abutting on the end  
of the said strip of land in the sum of \$127.22 as principal and  
the sum of \$60.01 as interest, and that the city pay said por-  
tion of the said lien.

Passed by the Council on the 21st day of November, 1922, by ~~an~~  
and nay vote taken on roll call of the council, all members elect-  
ed to the council and the vote entered in the journal of the coun-  
cil proceedings, all mebers <sup>present</sup> voting in favor of the said resolution  
Approved by the Mayor this 21st day of November, 1922,
