RESOLUTION NO. 5 FOR 1925.

A Resolution Declaring an Assessment for the Improvement of East Oak Street from a point 150.7 feet East of the Center of Cleveland Street East to the Center of River Street where the same bounds Riverside Addition on the East in Lebanon, Linn County, Oregon.

WHEREAS, on the 19th day of August, , 1924, a petition was filed for the improvement of East Oak Street from a point 150.7 feet East of the center of Cleveland Street East to the Center of River Street where the same bounds Riverside Addition on the East in Lebanon, Linn County, Oregon, and

WHEREAS, on the 19th day of August , 1924, the Common Council of the City of Lebanon duly enacted a resolution requiring the City Engineer and Superintendent of Streets of said City to prepare plans, specifications and estimates of the probable total cost of the making of said improvement, as asked for in the said petition, and

WHEREAS, on the 2nd day of September, 1924, the City Engineer and Superintendent of Streets of said City, filed with the Recorder their plans, specifications and estimates so made of the probable total cost of said improvement and that the estimates so made of the probable total cost of said improvement was the sum of \$500.00 and the estimate of the probable total cost of said improvement to be paid by the City of Lebanon was the sum of \$50.00 and that the estimate of the probable total cost of said improvement to be paid by the owners of the abutting real property and the real property especially benefited thereby was the sum of \$350.00, and

WHEREAS, the Council did on the 2nd day of September, 1924, duly adopt a resolution retifying and approving said plans, specifications and estimates of the probable total cost of said improvement and authorizing the work to be done by the City without advertising for bids for the same, as prayed for in said petition, and

WHEREAS, the City Engineer and Superintendent of Streets have made their report in writing and filed the same with the Recorder of said City showing that the said improvements have been fully completed according to the said petition and the plans and specifications therefor and that the total cost of making said improvement is the sum of \$246.32nd that the sum to be paid by the City of Lebanon is the sum of \$42.28 and that the sum to be paid by the owners of the abutting real property, is the sum of \$202.10

WHEREAS, the report of said improvement as filed by the City Engineer and Superintendent of Streets shows that the said improvement did not cost more than the estimate and in no case is the total cost more than the estimate against any lot or tract of land,

THEREFORE, be it resolved by the Common Council of the City of Lebanon, Oregon, that the report of the City Engineer and Superintendent of Streets be and the same is hereby ratified, approved and, in all things, confirmed, and
