Resolution No. 2 for 1926.

RASOLUTION OF INTENTION TO IMPROVE WILLIAMS STREET FROM THE NORTH LINE OF ISABELLE STREET TO THE SOUTH LINE OF DODGE STREET IN LEBALON, LINN COUNTY, OREGON.

WHEREAS, the City Council has heretofore deemed it expedient to improve that part of Williams Street above described and has, by resolution, required the City Engineer to prepare plans and specifications and an estimate of the work and the probable out total cost of said improvement; and

WHEREAS said Ingineer has duly made and filed with the Recorder plans and specifications for the improvement of said part of said street in accordance with said resolution; and

THEREAS the City Council has read and considered the plans and specifications of said City Ingineer now on file with the City Recorder and find the same to be proper.

THEREFORE, be it resolved that the City Council of Lebanon, Linn County, Oregon, approve said plans and specifications and the improvement therein provided for; and

Be it further resolved that the Council of the City of Lebanon deems it expedient and necessary and proposes to improve said part of Williams Street and does hereby declare its intention to improve said Villiams street from the North Line of Isabelle Street to the South line of Dodge Street in Lebanon, Linn County, Oregon, in the following manner, to-wit:

- 1. By grading the roadway of said street to proper grade;
- 2. By surfacing the center of the road way of said street for a width of twelve feet with crushed gravel and of proper thickness to make a good substantial road, the thickness of said surfacing to be determined by the Street Superintendent of the City of Lebanon;
- 3. By making proper drainage for said street.

That said improvement be made in accordance with the charter and ordinances of the City of Lebanon, Linn County, Oregon, and the plans, specifications and estimates of the City Engineer of said City for the improvement of said street, which said plans, specifications and estimates are on file in the office of the City Recorder of Lebanon, Linn County, Oregon, and endorsed: "Plans, specifications and estimates of cost for the improvement of Williams Street from the North line of Isabelle Street to the South line of Dodge Street."

Be it further resolved that the cost of grading of said street to proper subgrade be paid out of the road fund, general fund or other available fund of the City and that the cost of surfacing the road way of said street be assessed to the real property abutting thereon, it being the real property especially and particularly benefited thereby, as provided by the charter of said city.

The Angineer's estimate of the total probable cost of said improvement of said part of said street is as follows: \$225.00, and the part thereof to be paid by the City of Lebanon is \$100.00, and the part thereof to be paid by the abutting property owners is \$125.00.

The Council therefore hereby estimates and determines the total probable cost of making such improvement to be \$225.00, and that the probable cost to the City of Lebanon is \$100.00, and the probable cost to the abutting property owners is \$125.00

Be it further resolved that the Recorder of the City of Lebanon, Linn County, Oregon, be and he hereby is ordered and directed to give notice of said proposed improvement of Jilliams Street from the North Line of Isabelle Street to the South line of Dodge Street, as provided by the charter of said city.
