

RESOLUTION NO. 4 FOR 1926.

WHEREAS, the Superintendent of Streets of the City of Lebanon, Linn County, Oregon, has reported, in writing, to the Council of said City that the sidewalk on the North side of Isabella Street abutting upon the South side of Lot 14, Block 3, Kirkpatrick's Third Addition to the City of Lebanon, Linn County, Oregon, including the sidewalk intersection at the Northeast corner of Isabella and Hiatt streets in said city, has been torn out and there is now no sidewalk along said premises and that said sidewalk, when built, will accommodate a large number of the residents, residing in the Northeast part of the City of Lebanon; and

WHEREAS, the said Council finds and ascertains that there is no sidewalk along said described premises or at said sidewalk intersection along said described premises and that there should be a sidewalk constructed along said described premises and said sidewalk intersection in order to accommodate the public and especially the inhabitants of the Northeast part of the City of Lebanon; and

WHEREAS the Council finds and ascertains that said proposed sidewalk is within the cement sidewalk district of said city as provided by Ordinance ~~No. 128~~ and 74 of the said City of Lebanon, and that said walk should be re-built within the shortest possible time and in the manner prescribed by the ordinances of said city now in force and pertaining thereto; and

WHEREAS, the said Council finds and ascertains that the report of said Street Superintendent, on file herein, is correct and that the owner or reputed owner of said property upon which said sidewalk abutts is F.H. Stotler, whose

address is 4539 Edgware Street East, San Diego, California.

NOW, THEREFORE, be it resolved by the Common Council of the City of Lebanon, Linn County, Oregon, that the owner or owners of the above described lot and the sidewalk abutting thereon, as herein above described, shall build or cause to be built a cement sidewalk abutting upon said lot ~~14~~ above described, together with the sidewalk intersection at the North^{East} corner of Hiatt and Isabella Streets, which said sidewalk shall be 5 1/3 feet wide and constructed of cement, sand and gravel of the proper proportion to make what is known as a good cement sidewalk, which said walk shall be built on the established grade of the City and to be built and abutting upon the said Lot above described; and

BE IT FURTHER RESOLVED that the Council finds and ascertains and determines that the owner or reputed owner of said Lot and its post office address are as above set out and as reported by the Superintendent of Streets; and

BE IT FURTHER RESOLVED that said walk be built within twenty days from the date of this resolution and that it be built in accordance with the sidewalk ordinances now in force relating to the building of cement sidewalks, to-wit: Ordinance No. ; and

BE IT FURTHER RESOLVED; that notice to construct said sidewalk be given to the owner thereof and the owner of the abutting property in the manner provided by section 223 of the charter of the City of Lebanon, Linn County, Oregon now in force; and

BE IT FURTHER RESOLVED THAT said sidewalk be built without furnishing plans and specifications therefor by the owner of said lot; and

BE IT FURTHER RESOLVED that if the said owner or owners of said lot above described shall fail, refuse or neglect to build said sidewalk within the time herein ordered, then the said Superintendent of Streets of the City of Lebanon shall build the same as provided by the charter of said City of Lebanon and the ordinance thereof and keep an accurate account of the cost of labor and materials used in the building of such sidewalk in front of and abutting upon said lot, together with said sidewalk intersection at the Northwest^{2a} corner of Hiatt and Isabella Streets and shall report, as soon as completed, the cost of such sidewalk, together with the description of the lot fronting on said sidewalk so made, which said report shall be in writing and filed with the Recorder of the City of Lebanon.
