Resoultion No. 5 for 1926.

Whemeas the Superintendent of Streets of the City of Lebanon, Linn County, Oregon, has reported in writing to the City Council of said City that the sidewalk on the North side of Vine Street abotting upon the South side of the East 93 feet of Lot 8, block 2 Cowan's Addition to the City of Lebanon, Linn County, Oregon, is old, dilapitated and rotten and dangerous to persons travelling thereon and is in such condition that it cannot be repaired; and

Whereas the council finds and ascertains that the report of the said superintentent of streets is true and that said sidewalk is old, dilapitated, rotten and dangerous to persons travelling thereon; and that the same is in the thickly populated district of said city and accommodates a large number of persons, and

Whereas the Council finds and ascertains that said sidewalk is within the cement sidewalk district of said City as provided by Ordinances No. 128 and 74 of the said City, and that said sidewalk should be rebuilt within the shortest possible time and in the manner prescribed by the ordinances of said City now in force pertaining thereto; and

Whereas the Council finds and determines that the owner or reputed owners of said described lot or part thereof ix

WHEREAS' the City Engineer and Superintendent of Streets have made their report in writing and filed the same with the Recorder of said City showing that the said improvements have been fully completed according to the said petition and the plans and specifications therefor and that the total cost of making said improvement is the sum of \$179.45 and that the sum to be paid by the City of Lebanon is the sum of \$125.00 and that the sum to be paid by the owners of the abutting real property, is the sum of \$54.45.

WHEREAS, the report of said improvement as filed by the City Engineer and Superintendent of Streets shows that the said improvement did not cost more than the estimate and in no case is the total cost more than the estimate against any lot or tract of lans,

THEREFORE, be it resolved by the Common Council of the City of Lebanon, Oregon, that the report of the City Engineer and Superintendent of Streets be and the same is hereby ratified, approved and, in all things, confirmed, and

BE IT FURTHER RESOLVED, that the total cost of said improvement of Villiams Street from the North line of Isabella Street to the South line of Dodge Street is the sum of \$179.45, and that the portion thereof to be paid by the City of Lebanon is the sum of \$125.00 and that the portion thereof to be paid by the owners of the abutting real property and the real property especially benefited thereby is the sum of \$54.45, and
