RESOLUTION NO. 5  
1928

WHEREAS, John Summers, N. M. Newport and Fred Kerr, the directors of School District No.16 in Linn County Oregon, have on behalf of the said school District, filed a petition with the recorder of the city of Lebanon, Oregon, asking and petitioning for the vacation of all that portion and part of Morton Street between second Street and Third Street, in Lebanon, Oregon,

And it appearing from the said petition and from investigation, that the said School District No. 16 in Linn County, Oregon, owns all the real estate abutting on and adjacent to that portion of the said street asked to be vacated and that the petitioners are the only persons particularly affected by the vacation of the said portion of the said street.

And it further appearing to the Council from the said petition, that it is for best interest of the said petitioner and the city of Lebanon, and its inhabitants and the general public and all persons concerned that the said portion of the said street be vacated as prayed for <sup>in</sup> the said petition and that the prayer of the said petition be granted.

IT IS THEREFORE RESOLVED by the common council of the City of Lebanon in Linn County, Oregon, that the 7 day of Nov 1928, at the hour of 8 o'clock P. M. of said day at the council chambers in the said city of Lebanon, Oregon, be and the same is hereby fixed and set as the time and place for hearing any and all objections and remonstrances against the said petition or the vacation of the said portion of the said street as asked for in the said petition.

AND BE IT FURTHER RESOLVED by the Common Council of the said city of Lebanon, Oregon, that all persons having any objection or remonstrances to the said petition or the vacation of the said portion of the said street, file the same with the recorder of the said city of Lebanon,

Oregon, on or before the said time and that the same be heard at the said time and place.

AND BE IT FURTHER RESOLVED, by the said Council, that the recorder of the city of Lebanon, be and he is hereby directed to give due and legal notice to all persons concerned of the time and place of the said hearing, by posting notices in four public places in the city of Lebanon, Oregon, and where legal notices are usually posted therein, which said notices shall be posted at least thirty days before the time fixed and set for the said hearing, and if no objections or remonstrances are made or filed against the said petition or the said vacation of the said portion of the said street, the same will be taken as confessed and the said petition and vacation will be granted as prayed for.

Passed by the Council on this 18 day of September 1928, by an affirmative of a majority of all members elected to the Council, on roll call and vote taken by aye and nae vote and entered in the journal of the council proceedings.
