

RESOLUTION NO. 2 FOR 1932.

WHEREAS, the Superintendent of Streets of the City of Lebanon, Linn County, Oregon, has reported, in writing, to the Council of said City that the existing sidewalk on the South side of A Street between Main and Second Streets in Lebanon, Linn County, Oregon, which abuts upon the North side of Lot 1, Block 4, William Ralston's Addition to Lebanon, Linn County, Oregon, being 166 feet, more or less, extending from Main Street West along the North line of said Lot, is so dilapidated, rotten and out of repair that it is dangerous for people to travel over; and that it is so dilapidated and rotten that it is beyond repair; and that it is the sidewalk generally traveled by a large number of persons including school children, who use it in going to and from school; and

WHEREAS, the said Council finds and ascertains that said sidewalk is so dilapidated, rotten and out of repair that the same is dangerous to people who use it and that it is so rotten and dilapidated that it is beyond repair; and that there should be a new sidewalk constructed along said premises as above described in order to accommodate the public and especially the inhabitants residing in the vicinity thereof; and

WHEREAS, the Council finds and ascertains that said proposed sidewalk is without the cement sidewalk district of said City as provided by Ordinance No. 74 of the City of Lebanon; and that the same may be constructed in the manner provided by Ordinance No.        for 1930; and that the same should be rebuilt within the shortest possible time; and

WHEREAS, the said Council finds and ascertains that the report of the said Street Superintendent, on file herein, is correct and that the owner or reputed owner of said property, upon which said sidewalk abuts, is Theresa Beechler, and her postoffice address is Multnomah, Oregon.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Lebanon, Linn County, Oregon, that the owner or owners of the above described lot or tract of land and the sidewalk abutting thereon, as hereinabove described, shall build or cause to be built a regulation board sidewalk along the South line of A Street between Main and Second Streets and extending from Main Street West 166 feet and abutting upon the East 166 feet of Lot 1, Block 4, of William Ralston's Addition to Lebanon, Linn County, Oregon; and

BE IT FURTHER RESOLVED that the Council finds, ascertains and determines that the owner or reputed owner of said lot or tract of land is Theresa Beechler, and that her postoffice address is Multnomah, Oregon; and

BE IT FURTHER RESOLVED, that said sidewalk be built within thirty days from the date of this resolution and that it be built in accordance with the sidewalk ordinances now in force relating to the building of sidewalks that are not within the cement sidewalk district; and

BE IT FURTHER RESOLVED that notice to construct said sidewalk be given to the owner thereof and the owner of the abutting property, in the manner provided by Section 223 of the Charter of the City of Lebanon, Linn County, Oregon, now in force; and

BE IT FURTHER RESOLVED that said sidewalk be built without furnishing plans and specifications therefor by the owner of

said Lot; and

BE IT FURTHER RESOLVED that if the said owner or owners of said Lot, above described, shall fail, refuse or neglect to rebuild said sidewalk within the time herein required, then the said Superintendent of Streets of the City of Lebanon is hereby authorized and directed to build the same, in the manner provided by the Charter of the City of Lebanon and the ordinances governing the same, and keep an accurate account of the cost of labor and materials used in the building thereof, and as soon as completed, report the cost of such sidewalk, together with a description of the lot, parcel or tract of land fronting on said sidewalk so constructed, which said report shall be in writing and filed with the Recorder of the City of Lebanon, Linn County, Oregon.
