RESOLUTION NO. 17 FOR 1937

WHEREAS, A Petition signed by a large number of property owners and citizens of the City of Lebanon has been presented to the Common Council wherein it is alleged that sidewalks on the South side of Maple Street between Park and Grove Streets, and on the West side of Grove Street running South from Maple Street to the Lebanon and Santiam Canal are necessary for the use of the public and that there is heavy travel by pedestrians along said places, and

WHEREAS, Said sidewalks would abutt upon the property owned by Hugh Kirkpatrick and Maude R. Kirkpatrick, each of whose postoffice addresses are Lebanon, Oregon; and the property owned by George Crawford, whose postoffice address is Pendleton, Oregon; Ralph Crawford, whose postoffice address is Unknown; and Roy Crawford, whose postoffice address is Unknown

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL That said sidewalks are necessary for the use of the public and that the proposed sidewalks would be located inside the cement sidewalk district of the City of Lebanon, as provided by Ordinance No. 74, and that they should be built within the shortest possible time.

BE IT FURTHER RESOLVED That the owners of said real property abutting upon said proposed sidewalks are: Hugh Kirkpatrick and Maude R. Kirkpatrick, whose postoffice address is Lebanon, Oregon, and on whose property the proposed sidewalk abutts from the South East corner of the intersection of Park and Maple Streets Eastward on the South side of Maple Street a distance of feet, more or less, to the property line of the property the Council finds to

be owned by George Crawford, whose postoffice address is Pendleton, Oregon; Ralph Crawford, whose postoffice address is *Muthur*; and Roy Crawford, whose postoffice address is *Muthur*; and that the remainder of said proposed sidewalk would abutt upon the property of said owners last named from the East end of the Kirkpatrick sidewalk to the South West corner of the intersection of Maple and Grove Streets and from said corner South to the Lebanon and Santiam Canal.

BE IT FURTHER RESOLVED That said sidewalks be built within thirty (30) days from the date of this Resolution and that they be constructed in accordance with the sidewalk ordinances now in force relating to the building of cement sidewalks within the cement sidewalks district of said city.

BE IT FURTHER RESOLVED That Notice to Construct said sidewalks be given the owners of the real property upon which the same will abutt in the manner provided by the charter of the City of Lebanon and that said sidewalks be built without furnishing plans and specifications therefor by the owners of the real property.

BE IT FURTHER RESOLVED That if the owners of said real property, or any thereof, shall fail, refuse, or neglect to build said sidewalks, or any part thereof, within the time herein required, then the Superintendent of Streets of the City of Lebanon is hereby authorized and directed to build the same in the manner provided by the charter of said city and by ordinances governing the same, and he shall keep an accurate account of the cost of labor and materials used in building the sidewalks abutting on each piece of property and as soon as completed report the cost of said sidewalks, together with the description of the property on which they abutt, which report should be in writing and filed with the Recorder.
