

RESOLUTION NO. 29 FOR 1941

WHEREAS, The Common Council of the City of Lebanon, Linn County, Oregon, did by Ordinance No. 538, passed by said Council and approved by the Mayor of said City on the 6th day of May, 1941, order the laying of concrete paving upon certain streets, including that portion of Oak Street, between the West line of Main Street and the East line of the first alley West of Main Street within said City, which said paving was to be of a width of 32 feet; and

WHEREAS, All owners of property abutting upon said portion of Oak Street desire that the width of the paving along said portion be increased to 44 feet and have signed written statements to the effect that if the City will increase the width of said portion of Oak Street by laying additional strips of concrete each six feet in width, upon the North and South sides of said portion of Oak Street, that they will each pay all the costs and expenses incurred by the laying of said additional strips of concrete over and above the cost of the improvement provided for in said Ordinance No. 538.

NOW, THEREFORE, BE IT RESOLVED, That the City Engineer be and he hereby is ordered and directed to lay said strips of pavement six feet in width along the North and South sides respectively of the paving to be laid along said portion of Oak Street as provided in said Ordinance No. 538, in a manner and of a grade comparable to that provided in the plans and specifications of the work ordered by said Ordinance.

BE IT FURTHER RESOLVED, That the City Engineer keep an accurate account of the total additional costs occasioned by the laying of each of said strips in addition to the cost of the paving as provided in said Ordinance.

BE IT FURTHER RESOLVED, That the City Engineer lay said strips of concrete paving concurrently with the normal course of work in making the improvements provided in said Ordinance.

TO THE MAYOR AND COMMON COUNCIL OF THE CITY OF LEBANON, LINN COUNTY,
OREGON:

WHEREAS, by Ordinance No. 538, which was passed and approved on May 6, 1941, you have ordered the paving of Oak Street between the West line of Main Street and the East line of the first alley West of Main Street to the width of 32 feet, and the undersigned is the owner of the property abutting upon the North side of said portion of Oak Street, and desires that the width of said paving be increased by laying a strip of paving six feet wide along the North side of the paving as provided for in said Ordinance No. 538, and is willing to pay all costs and expenses of said additional strip of paving;

THEREFORE, The undersigned hereby promises and agrees that if the said City of Lebanon will pave or cause to be paved said six foot strip, that it will then upon demand pay unto said City all costs and expenses of paving said six foot strip incurred in addition to the paving as provided in said Ordinance.

It is understood that this offer does not in any way affect the assessment to be levied against the property of the undersigned on account of the paving to be done pursuant to said Ordinance.

TO THE MAYOR AND COMMON COUNCIL OF THE CITY OF LEBANON, LINE COUNTY,
