

RESOLUTION NO. 3 FOR 1942

WHEREAS, on the 10th day of June, 1942, the Common Council, acting with six freeholders chosen from the several wards of the City of Lebanon, as by law required, prepared an estimate or budget of all money necessary to be raised by taxation for the Fiscal year from July 1, 1942, to June 30, 1943, inclusive, for the purpose of conducting the business of said City for said period; and

WHEREAS 8:00 o'clock P. M., on Monday, the 6th day of July, 1942, in the Council room of the City building of Lebanon, Oregon, was set as the time and place for hearing said budget, and notice of such hearing was duly given as by law required, due proof of said notice being on file herein, and said hearing was on said date and at said time and place in said notice given duly and regularly held; and

WHEREAS a full and complete hearing was had upon said tentative budget and the Council, being the levying board of the City of Lebanon, being now fully advised as to the amount necessary to be raised by taxation for all purposes of said City for the Fiscal year from July 1, 1942, to June 30, 1943, which said amounts are as follows:
