NOTICE OF INTENTION TO IMPROVE GROVE STREET FROM GRANT STREET TO CAROLINA STREET

Notice is hereby given that the common council of the City of Lebanon, Oregon, deems it necessary and expedient and hereby declares its purpose and intention to improve Grove Street from North line of Grant to the North line of Carolina Street, in the City of Lebanon, Linn County, Oregon, at the expense of the abutting and adjacent property, except the alley and intersection, the expense of which will be assumed by the City of Lebanon, by bringing said portion of said street to the established grade, constructing cement concrete curbs, and paving said portion of said street with a 2-inch asphaltic concrete pavement thirty-two feet wide, in accordance with the plans and specifications therefore which were adopted by the common council May 4th, 1948, which are now on file in the office of the City Recorder and by this reference thereto are made apart thereof.

The common council hereby declares its purpose and intention to make the above described improvements by and through the street improvement departments.
