

WHEREAS the Street Committee of the City Council pursuant to authority vested in said committee by Section 35, Ordinance No. 567 as amended, has designated the areas hereinafter described as no parking areas and has also designated the location hereinafter specified for the erection of a non-stop sign and

WHEREAS said Committee has requested that their action be approved by resolution of the council.

NOW THEREFORE BE IT RESOLVED that the action of the Street Committee in designating the hereinafter described areas as areas where parking shall not be permitted and establishing the hereinafter describe stop street be and the same is hereby approved and that the following areas be and the same are hereby declared to be an areas in which no parking shall be permitted, to-wit:

The North and South side of Maple Street running West 22 feet from the West side of Park Street.

The North and South side of Academy Street running West from Main Street 30 feet.

The South side of Academy Street running East 20 feet from the East line of the Intersection of Academy Street and Second Street.

The West line of Second Street running South 30 feet from the South line of the intersection of Second Street and Academy Street.

The East side of Second Street running South 15 feet from the South line of the intersection of Second Street and Academy Street.

The Southerly side of Second Street running Northwesterly 40 feet from the West side of the intersection of Academy Street and Second Street; For the purpose of clarifying the foregoing designations the area bounded on the North by the Highschool grounds on the East by the continuation of the East line of Second Street running North on the South by the continuation of the South line of Academy Street running West and on the West by the continuation of the West line of Second Street running North shall be known as the intersection of Academy Street and Second Street.

The West side of Second Street running South 30 feet from the intersection of the South line of Tangent Street and the West line of Second Street.

Beginning at the intersection of the North line of Tangent Street extended to and West boundary of the Highschool grounds and running South along the East line of Second Street 58 feet.

The South side of Tangent Street running West 21 feet from the intersection of the South line of Tangent Street and the West line of Second Street.

The North and South side of Berry Street running East 21 feet from Main Street.

The North and South side of Jennings Street running East 21 feet from Main Street.

The West side of Main Street beginning with the North side of the Kuhn Theater extended, and running South to the South side of the Kuhn Theater extended.

Elmore Street South side extending West 390 feet from Grove Street.

Grove Street West side extending South 50 feet from the intersection of Elmore Street and Grove Street.

The East side of Park Street running South 60 feet from the intersection of Park Street and Sherman Street.


BE IT FURTHER RESOLVED that the following streets be and they are hereby designated as stop streets to-wit:

Tangent Street at the East side of the intersection of Tangent Street and Seventh Street.

Oak Street at the East side of the intersection of Seventh Street and Oak Street.

and that the Street Committee be and they are hereby authorized and directed to erect, at a suitable location to be selected by them, stop signs on Seventh Street adjacent to and South of the two intersections above mentioned.
