WHEREAS, a Petition has been received by the Common Council to improve a street running through the area hereinafter described, and

WHEREAS, the cost of installing drainage facilities in said area after the street is improved would be prohibitive, and

WHEREAS, it is necessary that lateral drainage lines be constructed before said street be improved, and it is necessary that lateral lines be constructed and it is for the best interest of the property owners and citizens residing in the property hereinafter described, and

WHEREAS, the City Engineer has made a study of the area hereinafter described and has recommended that the said area be drained, and

WHEREAS, the owners of the property hereinafter described will be especially benefit by the construction of said lateral drainage sewers, now therefore,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:
That the following described real property, to-wit:

Beginning at the Northwest corner of Lot 1, Block 5, Kirkpatrick's Addition to the City of Lebanon, Oregon; and running thence North along the East line of the Alley through Block 4, Kirkpatrick's Second Addition and to the South line of Block 3, Kirkpatrick's Second Addition, thence East to the Southeast corner of said Block 3, thence North along the East line of said Block 3 to the South line of Wheeler Street, thence East along said street line 246.86 feet, thence N. 1 degree 54' W. 210.11 feet to a point 150.0 feet North of the North line of Wheeler Street, thence East parallel to said street line to the Easterly boundary of the City of Lebanon, thence Southeasterly along the Easterly City boundary to the Northeast corner of Block 4, Kirkpatrick's Third Addition, thence Westerly along the North line of Block 4, said addition, the North line of Lots 4, 7 and 11 in Block 3, said addition, the North line of Lots 4 and 11, Block 2, said addition, and the North line of Lot 1, Block 5, Kirkpatrick's Addition to the place of beginning.

BE IT FURTHER RESOLVED, that the plans, specifications and estimates for the drainage of said District filed by the City Engineer be and the same are hereby adopted and approved.

BE IT FURTHER RESOLVED, that the City Recorder shall cause notice of intention to make said improvements in the manner provided by the Charter of the City of Lebanon.
