WHEREAS, the report of the Division Of Audits of the Office of the Secretary of State discloses that on June 30, 1956, there will exist a cash deficit in the City General Fund of approximately \$55,000.00 which resulted from the necessary increase in the City of Lebanon's general expenses due to increased population and the accompanying necessary increased services provided by the City Government, and

WHEREAS, the current cash deficit must be liquidated in order that the funds belonging to the Bancroft Bond and Interest Sinking Fund can be returned, said funds which should have been accumulated having heretofore been expended during the 1949-50 and 1953-54 fiscal years,

WHEREAS, it is the opinion of the Budget Committee and of the Common Council that the budget submitted by the Budget Committee provides for the minimum amount of expenditures and there will be a deficit in the sum of slightly in excess of \$60,000.00 if additional revenue is not obtained, and

WHEREAS, it is necessary and advisable that the Council submit to the legal electors of the City of Lebanon at a special election to be held on July 6, 1956 for their approval or rejection of proposed Amendments to the City Charter authorizing the City Council to replenish the existing deficit, purchase additional street equipment and make necessary additions in the sewage disposal plant and to issue and sell general obligation bonds in such an amount as will be sufficient to provide the additional sums of money required, now therefore,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON,

That there be submitted to the legal electors of said City for their approval or rejection at a special election to be held on July 6, 1956, the following proposed Charter Amendments and act authorizing a special tex levy.

CHAPTER XI

BOND ISSUE FOR THE PURPOSE OF AUTHORIZING FUNDS TO REPAY BANCROFT FUNDS HERETOFORE USED FOR CONSTRUCTION OF SEWAGE DISPOSAL PLANT AND FOR CONSTRUCTION OF SECONDARY CLARIFIER AT SEWAGE DISPOSAL PLANT AND FOR CONSTRUCTION OF A LEVEE AROUND SEWAGE DISPOSAL PLANT

Section 263 - BOND ISSUE - The City of Lebanon, Linn County, Oregon, acting by and thru its City Council is hereby authorized and empowered to construct a secondary clarifier at the existing sewage disposal plant and to build a levee around the City's sewage disposal for the purpose of preventing flood damage to the existing sewage disposal plant; and to replenish the existing deficit in the City of Lebanon's general fund in the sum of \$55,000.00, c incurred by said sums being previously used for the construction of the sewage disposal plant.

Section 264 - SALE OF BONDS - For the purpose of providing sufficient funds for the payment of the cost of construction of said secondary clarifier at the sewage disposal plant and building said levee, which sums are estimated to cost \$86,000.00 and for the replenishing of the existing deficit in said Bancroft funds to the extent of \$55,000.00, the Common Council of the City of Lebanon is hereby authorized, empowered and directed to issue and sell, as soon as shall be deemed expedient, convenient and necessary, negotiable bonds of the City of Lebanon, Linn County, Oregon, in the amount of \$141,000.00, or so much thereof as shall be deemed necessary to be used with other available funds for the purpose set out in Section 263.

Section 265 - SPECIFICATIONS OF BONDS - the Bonds hereby authorized shall be general obligation bonds of the City and shall mature at such time or times and may be in such form and of such denomination, due date, interest payable date, place of payment and shall bear such callable features and provisions as the Common Council may deem most likely to enhance their value and insure their saleability. Said bonds shall bear interest of a rate not greater than 4% per annum, and shall be sold for not less than 98 per centum of their par value and accrued interest.

Page 2 - Resolution No.

Section 266. - SPECIAL FUND - That the money derived from the sale of said bonds or any portion thereof shall constitute a special fund for the specific purposes therein designated and shall be used for no other purposes than herein specified.

Section 267 - ISSUANCE OF BONDS - The Common Council is hereby authorized and directed to issue and sell said bonds from time to time as they may be needed for the purposes hereinabove specified, but before any of said bonds shall be sold they shall be advertised for sale in the manner provided by law.

Section 268 - INDEBTEDNESS - The indebtedness authorized by this Amendment to the Charter of the City of Lebanon, in addition to all indebtedness authorized by the existing provisions of the Charter of the City of Lebanon.

Section 269 - REPAYMENT OF BONDS - The City Council shall make an additional special tax levy each year in a sum sufficient to pay the interest on the bonds hereby authorized and to retire the principal thereof as it matures. Neither the debt limitations nor the tax limitations contained in the Charter of the City shall apply to the bonds hereby authorized.

SECTION 1. That the ballot title for the ballot shall be as follows:

CHARTER AMENDMENT

Shall the Charter of the City of Lebanon, Oregon, be amended by adding thereto Chapter XI, providing for the issuance of \$141,000.00 bonds to provide funds with which to construct a secondary clarifier and a levee at the sewage disposal plant at a cost of \$86,000.00 and to replenish the existing deficit in the sum of \$55,000.00 and provide a tax levy to pay said bonds and interest thereon.

SECTION 2. That the proposition to be printed on the ballot shall be

as follows:

A proposition submitted to the legal electors of the City of Lebanon by the Common Council at a special election to be held in the City of Lebanon on the 6th day of July, 1956, for approval or rejection of a bond issue in the sum of \$141,000,00.

AND ALSO THE FOLLOWING PROPOSED CHARTER AMENDMENT CHAPTER XII. A BOND ISSUE FOR THE PURPOSE OF PURCHASING MEEDED STREET EQUIPMENT IN THE CITY OF LEBANON.

Section 270 - BOND ISSUE - The City of Lebanon, acting by and thru its City Council is hereby authorized and empowered to purchase a road grader, and a street sweeper.

Section 271- SALE OF BONDS - For the purpose of providing sufficient funds for the payment of a road grader and other necessary street equipment, the Common Council of the City of Lebanon is hereby authorized, empowered and directed to issue and sell, as soon as shall be deemed expedient, convenight and necessary, negotiable bonds of the City of Lebanon, Linn County, Oregon, in the amount of \$9,000.00 or so much thereof as shall be deemed necessary to be used with other available funds for the purpose set out in Section 270.

Section 272 - SPECIFICATIONS OF BONDS - The Bonds hereby authorized shall be general obligation bonds of the City and shall mature at such time or times and may be in such form and of such denomination, due date, interest payable date, place of payment and shall bear such callable features and provisions as the Common Council may deem most likely to enhance their value and insure their saleability. Said bonds shall bear interest of a rate not greater than 4% per annum, and **shall** be sold for not less than 98 per centum of their par value and accrued interest.

Section 273- SPECIAL FUND - That the money derived from the sale of said bonds or any portion thereof shall constitute a special fund for the specific purposes therein designated and shall be used for no other purposes than herein specified.

Section 274 - ISSUANCE OF BONDS - The Common Council is hereby authorized and directed to issue and sell said bonds from time to time as they may be needed for the purposes hereinabove specified, but before any of said bonds shall be sold they shall be advertised for sale in the manner provided by law.

Section 275- INDEBTEDNESS - The indebtedness authorized by this Amendment to the Charter of the City of Lebanoh, 15 in addition to all indebtedness authorized by the existing provisions of the Charter of the City of Lebanon.

Section 276 - REPAYNENT OF BONDS - The City Council shall make an additional special tax levy each year in a sum sufficient to pay the interest on the bonds hereby authorized and to retire the principal thereof as it matures. Neither the debt limitations nor the tax limitations contained in the Charter of the City shall apply to the bonds hereby authorized.

SECTION 1. That the ballot title for the ballot shall be as

follows:

CHARTER AMENDMENT

Shall the Charter of the City of Lebanon, Oregon be amended by adding thereto Chapter XII, providing for the issuance of \$9,000.00 bonds to provide funds with which to purchase street equipment, and providing a tax levy to pay said bonds and interest thereon. SECTION 2. That the proposition to be printed on the ballot shall be as

follows;

A proposition submitted to the legal electors of the City of Lebanon by the Common Council at a special election to be held in the City of Lebanon on the 6th day of July, 1956, for approval or rejection of a bond issue in the sum of \$9,000.00.

III.

AN ACT AUTHORIZING A SPECIAL LEVY FOR SEWAGE DISPOSAL PLANT, POLICE, FIRE, ENGINEER, PARKS, GENERAL GOVERN-MENT AND MISCELLANEOUS EXPENDITURE

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

SECTION 1. That the following proposition be submitted to the legal electors

of the City of Lebanon at said election:

That the City of Lebanon, Linn County, Oregon, by and thru its city council be, and it hereby is, authorized and empowered to levy a tax in the sum of \$61,256.00 against all taxable property within the corporate limits of said city outside the limitations imposed by Article XI, Section 2 of the Constitution of the State of Oregon for the fiscal year 1956-57 for the purpose of providing funds for the operation and maintenance of the sewage disposal plant, police department, fire department, engineering department, park department, general government and miscellaneous expenditures of the City of Lebanon, and for all or any one or combination of such purposes and to use the funds derived from such sale for such purposes and no other.

SECTION 2 - That the ballot title for the proposed proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and thru its City Council be authorized to levy for the purposes of providing and using funds for the operation and maintenance of the sewage disposal plant, police department, fire department, engineering department, park department, general government and miscellaneous expenditures of the said Citya tax in the sum of \$61,256.00 against all taxable property within the limits of said City outside the constitutional 6% limitation of the State of Oregon for the fiscal year 1956-57.

SECTION 3 - That the proposition to be printed on the ballot shall be as

follows:

A proposition submitted to the legal electors of the City of Lebanon by the Council at a special election to be held on the 6th day of July, 1956, for a tax in the sum of \$61,256.00 outside the constitutional limitation.

SECTION 1. That said proposed Amendments to the Charter of said City of Lebanon and proposal for authorization of a special levy shall be placed upon the official ballot by the City Recorder to be voted upon by the legal electors of the City of Lebanon at said election.

SECTION 4. That the Clerks and Judges of said election shall be as follows:
