NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

Section 1. That there be submitted to the legal electors of the City of Lebanon for their approval or rejection at a special election to be held on July 14, 1970, the following acts authorizing special levies.

PROPOSITION (1)

AN ACT AUTHORIZING A SPECIAL LEVY FOR THE PURPOSE OF PROVIDING FUNDS FOR THE OPERATION AND MAINTENANCE OF DEPARTMENTS OF THE GENERAL FUND:

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (a). That the proposition to be printed on the ballot shall be as follows:

> A proposition submitted to the legal electors of the City of Lebanon by its Common Council at a special election to be held on July 14, 1970, for a tax in the sum of \$183.395.00 outside the constitutional 6% limitation, for the fiscal tax year 1970-71 for

the purpose of providing funds for the operation and maintenance of departments of the General Fund, the estimated rate of tax necessary therefor being \$4.669 per \$1,000 of true cash value of all the taxable property within the City Limits, based on the 1969-70 assessed valuation.

Section (b). That the text and ballot title for the proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$183.395.00 at the estimated rate of \$4.669 per \$1,000 of true cash value against all the taxable property within the City Limits, and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1970-71, for the purpose of providing funds for the operation and maintenance of departments of the General Fund.

PROPOSITION (2)

'AN ACT AUTHORIZING A SPECIAL LEVY FOR THE PURPOSE OF PROVIDING FUNDS FOR THE OPERATION OF THE DOG CONTROL DEPARTMENT WITHIN THE CITY OF LEBANON:

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (a). That the proposition to be printed on the

ballot shall be as follows:

A proposition submitted to the legal electors of the City of Lebanon by its Common Council at a special election to be held on July 14, 1970, for a tax in the sum of \$8,805.00 outside the constitutional 6% limitation, for the fiscal tax year 1970-71, for the purpose of providing funds for the operation of the dog control department within the City of Lebanon, the estimated rate of tax necessary therefor being \$0.224 per \$1,000 of true cash value of all the taxable property within the City Limits, based on the 1969-70 assessed valuation.

<u>Section (b).</u> That the text and ballot title for the proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$8,805.00 at the estimated rate of \$0.22µ per \$1,000 of true cash value against all the taxable property within the City Limits and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1970-71 for the operation of the dog control department within the City of Lebanon.

Section 2. That said proposal for special levies be placed

on the official ballot by the City Recorder to be voted on by the legal electors of the City of Lebanon at said election.

<u>Section 3.</u> That the Recorder of the City of Lebanon is hereby authorized and directed to publish and post notices of said election in the manner provided by law.

Section 4. That the polling places for said election in the City of Lebanon shall be as follows:

<u>Section 7.</u> That the foregoing proposed special tax levy be forthwith filed with the City Recorder for submission by him to the legal electors of the City of Lebanon at a special election called for the purpose of voting on said Acts on the 14th day of July, 1970.
