RESOLUTION NO. 15
for 1970

WHEREAS, if the City of Lebanon is to maintain services commensurate with the existing services, it is necessary that the Common Council submit to the legal electors of the City of Lebanon at a special election to be held Tuesday, August 25, 1970, for their approval or rejection the budget proposed by the Budget Committee and the Common Council and a proposal for^a special levy as set forth the title above and set forth in full below:

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

Section 1. That there be submitted to the legal electors of the City of Lebanon for their approval or rejection at a special election to be held on August 25, 1970, the following act authorizing a special levy.

PROPOSITION

AN ACT AUTHORIZING A SPECIAL LEVY FOR THE PURPOSE OF PROVIDING FUNDS FOR THE OPERATION AND MAINTENANCE OF DEPARTMENTS OF THE GENERAL FUND:

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (a). That the proposition to be printed on the ballot shall be as follows:

A proposition submitted to the legal electors of the City of Lebanon by its Common Council at a special election to be held on August 25, 1970, for a tax in the sum of \$143,026.00 outside the constitutional 6% limitation, for the fiscal tax year 1970-71 for the purpose of providing funds for the operation and maintenance of departments of the General Fund, the

estimated rate of tax necessary therefor being \$3.641 per \$1,000.00 of true cash value of all the taxable property within the City Limits, based on the 1969-70 assessed valuation.

Section (b). That the text and ballot title for the proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$143,026.00 at the estimated rate of \$3.641 per \$1,000.00 of true cash value against all the taxable property within the City Limits, and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1970-71, for the purpose of providing funds for the operation and maintenance of departments of the General Fund.


Section 2. That said proposal for a special levy be placed on the official ballot by the City Recorder to be voted on by the legal electors of the City of Lebanon at said election.

Section 3. That the Recorder of the City of Lebanon is hereby authorized and directed to publish and post notices of said election in the manner provided by law.


Section 4. That Ordinance No. 1382 shall provide for the polling places, the Judges and Clerks, and the furnishing of supplies for the purpose of said election.

Section 5. That the foregoing proposed special tax levy be forthwith filed with the City Recorder for submission by him to the legal electors of the City of Lebanon at the aforesaid special election.
