That said improvements be, and they are hereby declared to be necessary and proper and for the best interests of the City of Lebanon.

That the City Recorder shall cause such notice of intention to make said improvements to be given as provided by the Charter of the City of Lebanon, said notice to be given by posting notices thereof in five public places in the City of Lebanon, Oregon, for aperiod of ten days, or by publication of said notice in a newspaper in the City of Lebanon for a period of ten days.
