Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$12,750. at the estimated rate of \$0.218 per \$1,000. of true cash value against all the taxable property within the City Limits, and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1973-74, for the continuance of ambulance service within the City of Lebanon and for the purchase of an ambulance?

Section 3. That the Recorder shall publish and post notices of said election as provided by law, and shall place said propositions
