RESOLUTION NO. 6
for 1973

WHEREAS the City Engineer filed herein plans, specifications and estimates for the construction of a storm sewer drainage system in the below described area, known as the Milton Street Drainage District,

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:


That it is necessary and proper that storm sewer drainage be provided for the Milton Street Drainage District, described as follows, to-wit:

That said plans, specifications and estimates, including the probable total cost of said improvements and the amount thereof to be borne and paid by the owners of the adjacent or abutting property, such being the property especially benefitted thereby, and the amount thereof to be borne by the City, be and they are in all respects approved, ratified and affirmed.

That said improvements be, and they are hereby declared to be necessary and proper and for the best interests of the City of Lebanon.


That the City Recorder shall cause such notice of intention to make said improvements to be given as provided by the Charter of the City of Lebanon, said notice to be given by posting notices thereof in five public places in the City of Lebanon, Oregon, for a period of ten days, or by publication of said notice in a newspaper in the City of Lebanon for a period of ten days.

MILTON STREET DRAINAGE DISTRICT

Beginning at the N.W. corner of Lot 6, Block 1, Robertson Addition thence S0°16'W 270 ft. to the SW corner of Lot 6, Robertson Addition thence West 500.75 ft. thence N. 45°E 235.37 ft. to the westerly line of that property owned by Willamette Industries; thence N46°32' W 58.00 ft. to a 5/8" rod thence N 36°06'W 244.2 ft. to a 3/4" pipe thence N26°W 179.98 ft. to a 5/8" rod; thence N 5° 05'W 99.00 ft. to a 5/8" rod; thence N 14° W. 66 ft. to a 5/8" rod; thence N 6° 15'W 129.65 ft. to a 3/8" rod; thence West 20.45 ft. to the SE corner lot 6 Block 1 Downing Addition; thence North 165.67 ft to the NE corner of Lot 5, Block 1 Downing Addition; thence West 10 ft. thence North 360 ft. to the South line of Milton Street; thence North westerly to a 1/2" pipe on the northline of Milton street; said iron pipe being the southeast corner of that tract of land described on page 253 Book 332 of Linn County Deed Records, thence N 18°24'W 880.68 ft. to the center line of Elmore street thence East 13.86 ft. to the East line of River Street, thence north to the South line of the Burlington Northern Railroad right-of-way; thence westerly along said right-of-way to the East line of Franklin street; thence south to a point on the east line of Franklin street and the center of Lot 11, Block 1, Mitsch Addition thence East 148.0 ft. to the west line of Lot 18, Block 1 Mitsch Addition; thence South along the west line of Lots 18 through 28, Block 1, Mitsch Addition 607.09 ft. to the north line of Milton Street, thence East along said North line of Milton street to a point due north of the northwest corner of Lot 1, Block 4 of Downing Addition thence south along the West line of Downing Addition to the North line of Block 1, Landstrom thence West along said North line of Block 1, Landstroms addition, to the Easterly line of Park drive thence southerly along the Easterly line of Par Park Drive to the Northwest corner of Lot 11, Block 2 Landstroms Addition; thence west 125 ft. thence south 99.5 ft. to the north line of Lot 1, Block 1 of Edes Addition, thence West 42.38 ft. to a point 117.38 ft. west of the west line of Park drive thence south parallel to the west line of Park Drive, 333.26 ft. to a point due west of the Point of beginning, thence east to the P.O.B.
