RESOLUTION NO. 7  
For 1973

WHEREAS the City Engineer has filed herein plans, specifications and estimates for the street improvement district for the paving of the streets hereinafter named and described,

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

That said plans, specifications and estimates for the paving of Carolina Street from Ninth to Tenth Street; Ninth Street from Carolina to Academy Street; Fifteenth Street from Sherman to Vine Street; Fourteenth Street from Sherman to Vine Street; Twelfth Street from Sherman to Vine Street; Twelfth Street from Sherman to Maple Street; Ash Place; Wendell Street from end of existing paving East to Second Street; Third Street from Wendell to Wassom Street; Post Street from Milton to Ralston Drive; Acorn Street from Walker Road to Rose Drive; Hiatt Street from Elmore to Milton Street, including the probable total cost of said improvements and the amount thereof to be borne and paid by the owners of the adjacent or abutting property, such being the property especially benefitted thereby, and the amount thereof to be borne by the City, be and they are in all respects approved, ratified and affirmed.

That said improvements be and they are hereby declared to be necessary and proper and for the best interest of the City of Lebanon.

That the City Recorder shall cause such notice of intention to make said improvements to be given as provided by the Charter of the City of Lebanon, said notice to be given by posting notices thereof in five public places in the City of Lebanon, Oregon, for a period of ten days, or by publication of said notice in a newspaper in the City of Lebanon, Oregon, for a period of ten days.
