BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

That there be submitted to the legal voters of the City of Lebanon for their approval or rejection at a special election to be held on the 4th day of June, 1974, a proposed amendment to the Charter of the City of Lebanon, as follows:

CHAPTER XVIII

Section 1. The Council of the City of Lebanon is authorized to issue and sell general obligation bonds of the City in the sum of \$260,345.00 to provide funds to purchase equipment, acquire and prepare a site, furnish all necessary utilities, sewage and drainage, grade surface, and improve streets pertinent to the site, and to design, construct, furnish, and put in operable condition a fire hall at the intersection of 12th and Oak Streets, all in conjunction with the Lebanon Rural Fire Protection District. Said bonds shall be in such form and mature as determined by the Council.

Section 2. The Council of the City shall include in the annual tax levy a special additional levy in a sum sufficient to pay the principal and interest on the bonds hereby authorized as it becomes due.

BE IT FURTHER RESOLVED: that the ballot shall appear as follows:

BALLOT TITLE

A proposed Charter Amendment submitted to electors of the City of Lebanon by the Common Council at a special election to be held in the City on June 4, 1974, for approval or rejection of a bond issue in the sum of \$260,345.00, to provide funds to purchase equipment, acquire and prepare a site, furnish all necessary utilities, sewage and drainage, grade surface and improve streets pertinent to the site, and to design, construct, furnish, and put in operable condition a fire hall at the intersection of 12th and Oak Streets, in conjunction with the Lebanon Rural Fire Protection District.
