

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

That there be submitted to the legal voters of the City of Lebanon for their approval or rejection at a special election to be held on the 7th day of October, 1975, a proposed amendment to the Charter of the City of Lebanon, as follows:

CHAPTER XIX

Section 1. The Council of the City of Lebanon is authorized to issue and sell general obligation bonds of the City in the sum of \$990,000.00 to provide funds to design, prepare site, construct, inspect, equip, furnish and make operable a sewage treatment plant at present plant site, and sewage pump-station and 12" pressure line at west end of Harrison Street, and to cover the engineering, legal and administrative expenses; all in conjunction with a Federal E.P.A. Grant and the completion of its requirements. Said bonds shall be in such form and mature as determined by the Council.

Section 2. The Council of the City shall include in the annual tax levy a special additional levy in a sum sufficient to pay the principal and interest on the bonds hereby authorized as it becomes due.

BE IT FURTHER RESOLVED: That the ballot shall appear as follows:

BALLOT TITLE

A proposed Charter Amendment submitted to electors of City of Lebanon by the Common Council at a special election to be held in the City October 7, 1975, for approval or rejection of bond issue of \$990,000.00 to provide funds to design, prepare site, construct, inspect, equip, furnish and make operable a sewage treatment plant at present plant site, and sewage pump-station and 12" pressure line at west end of Harrison Street, and to cover the engineering, legal and administrative expenses; all in conjunction with a Federal E.P.A. Grant and the completion of its requirements.

CHARTER AMENDMENT
SUBMITTED TO THE VOTERS BY THE COUNCIL

Shall the Charter of the City of Lebanon be amended by adding thereto Chapter XIX providing for the issuance of general obligation bonds of the City in the sum of \$990,000.00 to provide funds to design, prepare site, construct, inspect, equip, furnish and make

operable a sewage treatment plant and sewage pump-station (\$2,673,750.00 of the cost is to be paid by a Federal E.P.A. Grant), which bonds shall be in such form, be dated and mature as determined by the Council; and authorizing a tax levy to pay the principal and interest on said bonds?

BE IT FURTHER RESOLVED:


