<u>Section III</u>: That the City Treasurer is authorized to transfer \$500.00 to the Scoop Stretcher line item, from Vehicle Operation line item. This transfer is in the Ambulance Department, Ambulance Fund.

<u>Section IV</u>: That the city Treasurer is authorized to transfer \$2,200.00 to the Treatment Plant Operators salary, from the Operating Contingency line item. This transfer is in the Sewer Department, Sewer Fund.
